## **Transaction Summary**

The transaction closed on Sep 29 2015 and matures in May 2026. The pool's current aggregate principal balance is \$903.9 million compared to \$939.7 million at close.

The largest loan of the pool (11.0%) is secured by Illinois Center located in metropolitan area. Occupancy at the subject was 74%. The major tenants included United States Government (8.80%) and Banker's Life (6.57%). The second largest loan of the pool (10.1%) is secured by Hammons Hotel Portfolio located in Dallas-Plano-Irving, TX-6.63% metropolitan area. Occupancy at the subject was 72%. The third largest loan of the pool (7.2%) is secured by The Decoration & Design Building located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 92%. The major tenants included Square parking (6.46%) and Stark Carpet (6.30%).

age (WALA) were 4.59% and 64 months as of 12/10/2020, respectively. There are a total of 62 loans and 90 properties in the portfolio. The appraisal LTV was approximately 64.6% compared to the Original loan to value (LTV), which was approximately 66.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.94x. As of 12/10/2020, 0.74% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 86%.





### Occupancy Distribution (%)




#### Local Distribution



Among assets in the portfolio, there are 14 properties (18% of total balance) located in Illinois, 7 properties (15% of total balance) in California, 4 properties (8% of total balance) in New York, 12 properties (7% of total balance) in Texas, 8 properties (7% of total balance) in Florida, 4 properties (6% of total balance) in North Carolina and 4 properties (6% of total balance) in Michigan. 



Most recent net operating income debt yield ranged from 6% to 23% with a weighted average NOI debt yield of 11.6%. NOI debt yield ranged from 6% to 23%. There were 7 assets (8% of total balance) with NOI debt yield between 6% and 8%, 13 assets (12% of total balance) with NOI debt yield between 8% and 10%, 20 assets (41% of total balance) with NOI debt yield between 10% and 12%, 8 assets (19% of total balance) with NOI debt yield between 12% and 14%, 9 assets (16% of total balance) with NOI debt yield between 14% and 16%, 4 assets (3% of total balance) with NOI debt yield between 16% and 18%, 1 assets (1% of total balance) with NOI debt yield between 22% and 24%

NCF DSCR ranged from 0.0x to 4.0x. There were 4 assets (3.9% of total balance) with NCF DSCR between 0.5x and 1.0x, 16 assets (15.9% of total balance) with NCF DSCR between 1.0x and 1.5x, 22 assets (42.4% of total balance) with NCF DSCR between 1.5x and 2.0x, 13 assets (26.2% of total balance) with NCF DSCR between 2.0x and 2.5x, 4 assets (9.0% of total balance) with NCF DSCR between 2.5x and 3.0x, 2 assets (2.1% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (0.5% of total balance) with NCF DSCR between 3.5x and 4.0x. The most recent weighted average NCF DSCR was 1.9x.







DSCRs ranged from 1.0x to 4.0x.There are 17 assets (15.9% of total balance) with DSCR between 1.0x and 1.5x, 20 assets (22.8% of total balance) with DSCR between 1.5x and 2.0x, 15 assets (34.5% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (17.0% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (8.2% of total balance) with DSCR between 3.0x and 3.5x and 2 assets (1.6% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 2.1x.

There are 1 assets (0.7% of total balance) that have maturity dates between 2020/7 and 2020/12, 2 assets (4.4% of total balance) that have maturity dates between 2025/1 and 2025/6, 58 assets (87.7% of total balance) that have maturity dates between 2025/7 and 2025/12 and 1 assets (7.2% of total balance) that have maturity dates between 2026/1 and 2026/6.

## Summary

EJR used the capitalization rates ("cap rates") listed below for the different types of the properties and then calculated the value of the properties in the portfolio by considering the most recent NCF and the various cap rates.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
