Transaction Summary

The transaction closed on Sep 29 2015 and matures in May 2026. The pool's current aggregate principal balance is \$882.7 million compared to \$932.4 million at close.

The largest loan of the pool (11.0%) is secured by Illinois Center located in metropolitan area. Occupancy at the subject was 61%. The major tenants included United States Government (8.41%) and Banker's Life (6.56%). The second largest loan of the pool (10.5%) is secured by Hammons Hotel Portfolio located in Dallas-Plano-Irving, TX-6.63% metropolitan area. Occupancy at the subject was 56%. The third largest loan of the pool (7.3%) is secured by The Decoration & Design Building located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 77%. The major tenants included SQUARE PARKING SYS (6.46%) and Stark Carpet (6.30%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.59% and 80 months as of 04/10/2022, respectively. There are a total of 61 loans and 89 properties in the portfolio. The appraisal LTV was approximately 64.4% compared to the Original loan to value (LTV), which was approximately 66.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.46x. As of 04/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 75%.

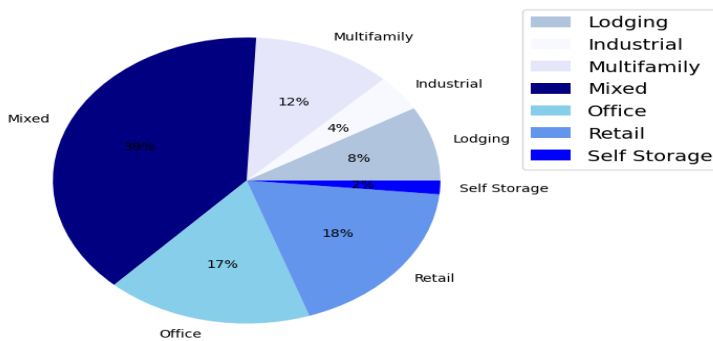

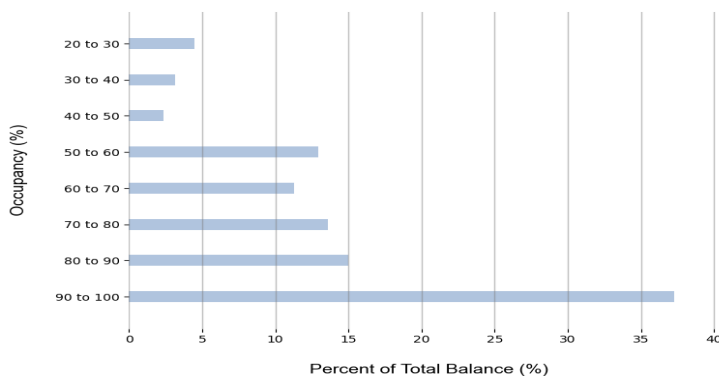

Occupancy Distribution (%)

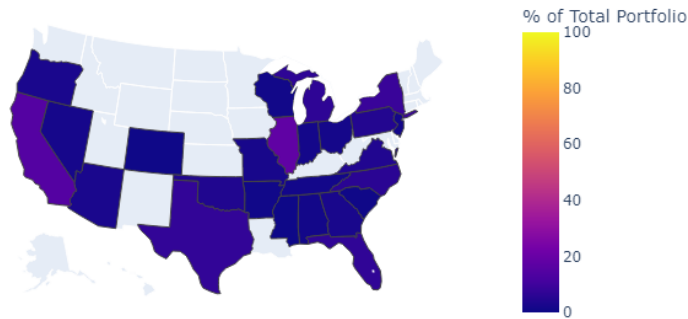

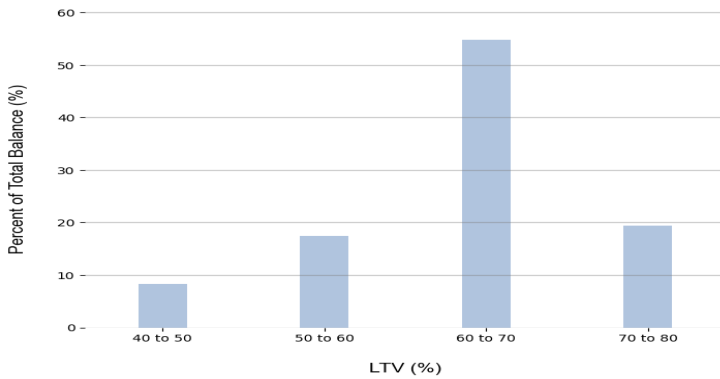
Local Distribution



Among assets in the portfolio, there are 14 properties (18% of total balance) located in Illinois, 7 properties (15% of total balance) in California, 4 properties (9% of total balance) in New York, 12 properties (7% of total balance) in Texas, 8 properties (7% of total balance) in Florida, 4 properties (6% of total balance) in Michigan and 3 properties (6% of total balance) in North Carolina. Other properties are located in the state of Virginia, Oklahoma, Arizona, Oregon, Georgia, Missouri, Nevada, Ohio, New Jersey, Indiana, Tennessee, Alabama, Wisconsin, Arkansas, South Carolina, Colorado and Mississippi.

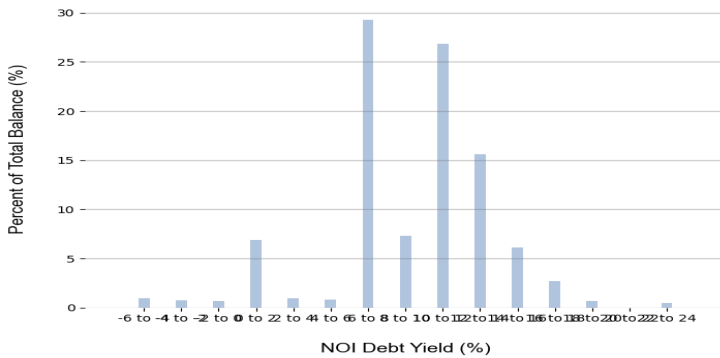

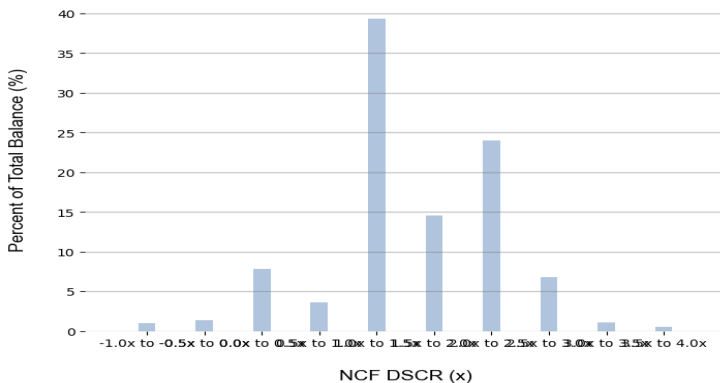
NOI Debt Yield (%)

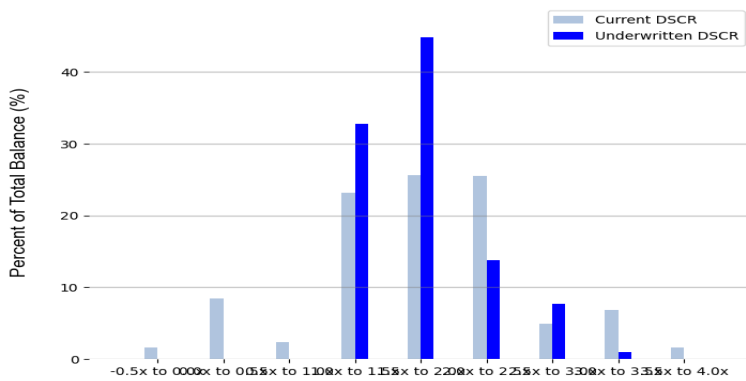

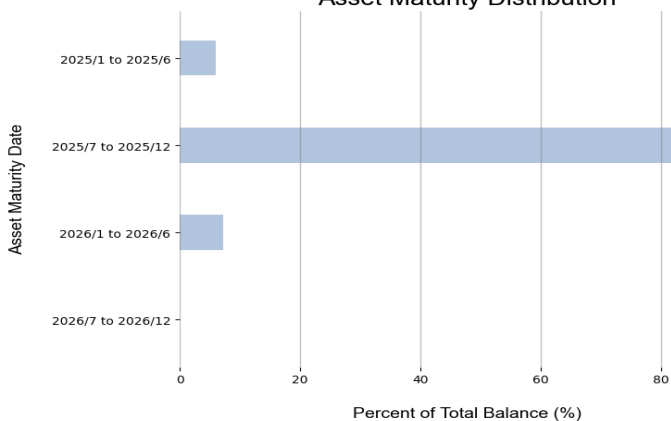
DSCR Distribution (x)



DSCRs ranged from -0.5x to 4.0x. There are 2 assets (1.7% of total balance) with DSCR between -0.5x and 0.0x, 5 assets (8.5% of total balance) with DSCR between 0.0x and 0.5x, 4 assets (2.4% of total balance) with DSCR between 0.5x and 1.0x, 13 assets (23.1% of total balance) with DSCR between 1.0x and 1.5x, 15 assets (25.6% of total balance) with DSCR between 1.5x and 2.0x, 17 assets (25.5% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (4.9% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (6.8% of total balance) with DSCR between 3.0x and 3.5x and 2 assets (1.6% of total balance) with DSCR between 3.5x and 4.0x. There are 3 assets (52.8% of total balance) that have maturity dates between 2025/1 and 2025/6, 57 assets (765.9% of total balance) that have maturity dates between 2025/7 and 2025/12 and 1 assets (64.0% of total balance) that have maturity dates between 2026/1 and 2026/6.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.


