Transaction Summary

The transaction closed on Jun 01 2016 and matures in Jun 2026. The pool's current aggregate principal balance is \$722.9 million compared to \$756.3 million at close.

The largest loan of the pool (13.1%) is secured by The Strip located in metropolitan area. Occupancy at the subject was 94%. The major tenants included Walmart (18.99%) and Lowe's Home Improvement (16.58%). The second largest loan of the pool (9.1%) is secured by OZRE Leased Fee Portfolio located in Montgomery County-Bucks County-Chester County, PA-19.79% Camden, NJ-16.67% Washington-Arlington-Alexandria, DC-VA-MD-WV-5.56% metropolitan area. Occupancy at the subject was 100%. The major tenants included PPD (5.26%) and Paralion Holdings LLC (3.95%). The third largest loan of the pool (7.4%) is secured by Hyatt Regency Huntington Beach Resort & Spa located in Anaheim-Santa Ana-Irvine, CA metropolitan area. Occupancy at the subject was 78%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.98% and 54 months as of 10/10/2020, respectively. There are a total of 54 loans and 130 properties in the portfolio. The appraisal LTV was approximately 63.7% compared to the Original loan to value (LTV), which was approximately 66.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.64x. As of 10/10/2020, 1.83% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.





Occupancy Distribution (%)




Local Distribution





There were 1 assets (1.8% of total balance) with NCF DSCR between -1.0x and -0.5x, 1 assets (0.3% of total balance) with NCF DSCR between 0.0x and 0.5x, 4 assets (3.2% of total balance) with NCF DSCR between 0.5x and 1.0x, 18 assets (36.3% of total balance) with NCF DSCR between 1.0x and 1.5x, 22 assets (34.8% of total balance) with NCF DSCR between 1.5x and 2.0x, 6 assets (21.4% of total balance) with NCF DSCR between 2.5x and 2.5x and 2 assets (2.1% of total balance) with NCF DSCR between 2.5x and 3.0x. 



EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
