Transaction Summary

The transaction closed on Jun 01 2016 and matures in Jun 2026. The pool's current aggregate principal balance is \$693.3 million compared to \$742.1 million at close.

The largest loan of the pool (13.2%) is secured by The Strip located in metropolitan area. Occupancy at the subject was 100%. The major tenants included Walmart (18.99%) and Lowe's Home Improvement (16.58%). The second largest loan of the pool (9.5%) is secured by OZRE Leased Fee Portfolio located in Montgomery County-Bucks County-Chester County, PA-19.79% Camden, NJ-16.67% Washington-Arlington-Alexandria, DC-VA-MD-WV-5.56% metropolitan area. Occupancy at the subject was 100%. The major tenants included PPD (5.09%) and Paralion Holdings LLC (3.95%). The third largest loan of the pool (7.6%) is secured by Hyatt Regency Huntington Beach Resort & Spa located in Anaheim-Santa Ana-Irvine, CA metropolitan area. Occupancy at the subject was 61%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.97% and 72 months as of 04/10/2022, respectively. There are a total of 53 loans and 129 properties in the portfolio. The appraisal LTV was approximately 63.2% compared to the Original loan to value (LTV), which was approximately 66.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.53x. As of 04/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.





Occupancy Distribution (%)




Local Distribution





There were 1 assets (2.8% of total balance) with NCF DSCR between -0.5x and 0.0x, 1 assets (0.3% of total balance) with NCF DSCR between 0.0x and 0.5x, 3 assets (2.5% of total balance) with NCF DSCR between 0.5x and 1.0x, 23 assets (43.7% of total balance) with NCF DSCR between 1.0x and 1.5x, 17 assets (37.7% of total balance) with NCF DSCR between 1.5x and 2.0x, 4 assets (8.5% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (3.8% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (0.6% of total balance) with NCF DSCR between 3.0x and 3.5x. 



There are 1 assets (2.8% of total balance) with DSCR between -0.5x and 0.0x, 1 assets (0.3% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (1.2% of total balance) with DSCR between 0.5x and 1.0x, 20 assets (38.9% of total balance) with DSCR between 1.0x and 1.5x, 17 assets (40.4% of total balance) with DSCR between 1.5x and 2.0x, 7 assets (6.9% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (8.9% of total balance) with DSCR between 2.5x and 3.0x and 1 assets (0.6% of total balance) with DSCR between 3.0x and 3.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
