Transaction Summary

The transaction closed on Nov 17 2016 and matures in Nov 2028. The pool's current aggregate principal balance is \$730.8 million compared to \$757.7 million at close.

The largest loan of the pool (8.9%) is secured by Briarwood Mall located in metropolitan area. Occupancy at the subject was 97%. The major tenants included Macy's (50.54%) and JC Penney (41.58%). The second largest loan of the pool (7.9%) is secured by The Townhouse Apartments - Stamford located in metropolitan area. Occupancy at the subject was 94%. The third largest loan of the pool (7.7%) is secured by 101 Hudson located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 75%. The major tenants included Merrill Lynch (28.63%) and Tullett Prebon Holdings Corp. (7.44%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.14% and 50 months as of 12/15/2020, respectively. There are a total of 44 loans and 72 properties in the portfolio. The appraisal LTV was approximately 58.2% compared to the Original loan to value (LTV), which was approximately 60.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.15x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.



Type Concentration





Occupancy Distribution (%)







Most recent net operating income debt yield ranged from 4% to 17% with a weighted average NOI debt yield of 11.2%. NOI debt yield ranged from 4% to 17%. There were 1 assets (2% of total balance) with NOI debt yield between 4% and 6%, 1 assets (8% of total balance) with NOI debt yield between 6% and 8%, 8 assets (19% of total balance) with NOI debt yield between 8% and 10%, 18 assets (37% of total balance) with NOI debt yield between 10% and 12%, 8 assets (21% of total balance) with NOI debt yield between 12% and 14%, 3 assets (7% of total balance) with NOI debt yield between 14% and 16% and 5 assets (7% of total balance) with NOI debt yield between 16% and 18%.

NCF DSCR ranged from 0.0x to 4.0x. There were 2 assets (3.5% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (4.3% of total balance) with NCF DSCR between 0.5x and 1.0x, 10 assets (12.4% of total balance) with NCF DSCR between 1.0x and 1.5x, 15 assets (36.7% of total balance) with NCF DSCR between 1.5x and 2.0x, 5 assets (9.3% of total balance) with NCF DSCR between 1.5x and 2.0x, 5 assets (9.3% of total balance) with NCF DSCR between 2.5x and 3.0x, 3 assets (9.0% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (4.8% of total balance) with NCF DSCR between 4.0x and 4.5x. 



DSCRs ranged from 0.0x to 4.5x. There are 8 assets (22.5% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (1.5% of total balance) with DSCR between 0.5x and 1.0x, 7 assets (8.6% of total balance) with DSCR between 1.0x and 1.5x, 12 assets (27.6% of total balance) with DSCR between 1.5x and 2.0x, 4 assets (3.8% of total balance) with DSCR between 2.0x and 2.5x, 7 assets (13.2% of total balance) with DSCR between 2.0x and 3.5x and 1 assets (4.8% of total balance) with DSCR between 4.0x and 4.5x. The most recent weighted average DSCR is 2.4x.

There are 3 assets (6.1% of total balance) that have maturity dates between 2021/7 and 2021/12, 1 assets (0.9% of total balance) that have maturity dates between 2025/7 and 2025/12, 39 assets (88.9% of total balance) that have maturity dates between 2026/7 and 2026/12 and 1 assets (4.1% of total balance) that have maturity dates between 2028/7 and 2028/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
