Transaction Summary

The transaction closed on Nov 17 2016 and matures in Nov 2028. The pool's current aggregate principal balance is \$652.7 million compared to \$687.2 million at close.

The largest loan of the pool (10.0%) is secured by Briarwood Mall located in metropolitan area. Occupancy at the subject was 74%. The major tenants included Forever 21 (4.31%) and Victoria's Secret (3.85%). The second largest loan of the pool (8.9%) is secured by The Townhouse Apartments - Stamford located in metropolitan area. Occupancy at the subject was 88%. The third largest loan of the pool (8.6%) is secured by 101 Hudson located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 73%. The major tenants included Merrill Lynch (38.35%) and TP ICAP AMERICAS HOLDINGS INC (7.43%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.11% and 66 months as of 04/15/2022, respectively. There are a total of 41 loans and 68 properties in the portfolio. The appraisal LTV was approximately 56.7% compared to the Original loan to value (LTV), which was approximately 60.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.04x. As of 04/15/2022, 1.01% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 83%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 0% to 19% with a weighted average NOI debt yield of 10.2%. NOI debt yield ranged from 0% to 19%. There were 2 assets (3% of total balance) with NOI debt yield between 0% and 2%, 1 assets (2% of total balance) with NOI debt yield between 4% and 6%, 2 assets (10% of total balance) with NOI debt yield between 6% and 8%, 12 assets (40% of total balance) with NOI debt yield between 8% and 10%, 12 assets (19% of total balance) with NOI debt yield between 10% and 12%, 8 assets (23% of total balance) with NOI debt yield between 12% and 14%, 1 assets (1% of total balance) with NOI debt yield between 14% and 16%, 1 assets (1% of total balance) with NOI debt yield between 16% and 18%, 2 assets (2% of total balance) with NOI debt yield between 18% and 20%

There were 1 assets (1.0% of total balance) with NCF DSCR between -0.5x and 0.0x, 2 assets (3.9% of total balance) with NCF DSCR between 0.0x and 0.5x, 3 assets (6.1% of total balance) with NCF DSCR between 0.5x and 1.0x, 9 assets (14.3% of total balance) with NCF DSCR between 1.0x and 1.5x. 13 assets (32.9% of total balance) with NCF DSCR between 1.5x and 2.0x, 4 assets (17.6% of total balance) with NCF DSCR between 2.0x and 2.5x, 6 assets (13.3% of total balance) with NCF DSCR between 2.5x and 3.0x, 2 assets (5.4% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (5.4% of total balance) with NCF DSCR between 3.5x and 4.0x. 



DSCRs ranged from 0.0x to 4.5x.There are 7 assets (20.7% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (4.0% of total balance) with DSCR between 0.5x and 1.0x, 8 assets (15.8% of total balance) with DSCR between 1.0x and 1.5x, 11 assets (23.8% of total balance) with DSCR between 1.5x and 2.0x, 2 assets (1.6% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (14.0% of total balance) with DSCR between 2.5x and 3.0x, 4 assets (14.8% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (5.4% of total balance) with DSCR between 4.0x and 4.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
