Transaction Summary

The transaction closed on Apr 26 2016 and matures in Apr 2026. The pool's current aggregate principal balance is \$637.9 million compared to \$663.2 million at close.

The largest loan of the pool (11.0%) is secured by Sheraton Denver Downtown Fee located in metropolitan area. Occupancy at the subject was 100%. The second largest loan of the pool (6.9%) is secured by Williams Mullen Center located in metropolitan area. Occupancy at the subject was 99%. The major tenants included Williams Mullen PC (82.78%) and Capital One (6.35%). The third largest loan of the pool (6.3%) is secured by 79 Madison Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included WW 79 MADISON LLC (75.04%) and TED MOUDIS ASSOCIATES INC (13.13%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.95% and 60 months as of 01/10/2021, respectively. There are a total of 51 loans and 60 properties in the portfolio. The appraisal LTV was approximately 63.6% compared to the Original loan to value (LTV), which was approximately 65.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.63x. As of 01/10/2021, 1.01% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.





Occupancy Distribution (%)





Local Distribution






NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 6% to 19% with a weighted average NOI debt yield of 10.3%. NOI debt yield ranged from 6% to 19%. There were 2 assets (12% of total balance) with NOI debt yield between 6% and 8%, 18 assets (50% of total balance) with NOI debt yield between 8% and 10%, 11 assets (11% of total balance) with NOI debt yield between 10% and 12%, 12 assets (16% of total balance) with NOI debt yield between 12% and 14%, 4 assets (9% of total balance) with NOI debt yield between 14% and 16%, 3 assets (1% of total balance) with NOI debt yield between 16% and 18% and 1 assets (0% of total balance) with NOI debt yield between 18% and 20%.

All assets in the portfolio had net cash flow debt service coverage ratios (NCF DSCR) higher than 1x. NCF DSCR ranged from 1.0x to 3.0x. There were 13 assets (32.4% of total balance) with NCF DSCR between 1.0x and 1.5x, 28 assets (52.0% of total balance) with NCF DSCR between 1.5x and 2.0x, 9 assets (15.5% of total balance) with NCF DSCR between 2.0x and 2.5x and 1 assets (0.1% of total balance) with NCF DSCR between 2.5x and 3.0x. The most recent weighted average NCF DSCR was 1.6x.







DSCRs ranged from 1.0x to 3.0x. There are 13 assets (32.4% of total balance) with DSCR between 1.0x and 1.5x, 26 assets (51.0% of total balance) with DSCR between 1.5x and 2.0x, 7 assets (7.8% of total balance) with DSCR between 2.0x and 2.5x and 5 assets (8.8% of total balance) with DSCR between 2.5x and 3.0x. The most recent weighted average DSCR is 1.7x

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
