Transaction Summary

The transaction closed on Apr 26 2016 and matures in Apr 2026. The pool's current aggregate principal balance is \$589.1 million compared to \$638.6 million at close.

The largest loan of the pool (11.9%) is secured by Sheraton Denver Downtown Fee located in metropolitan area. Occupancy at the subject was 100%. The second largest loan of the pool (7.0%) is secured by Williams Mullen Center located in metropolitan area. Occupancy at the subject was 99%. The major tenants included Williams Mullen PC (77.69%) and CHERRY BEKAERTH & HOLLAND LLP (10.19%). The third largest loan of the pool (6.8%) is secured by 79 Madison Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included WW 79 MADISON LLC (75.04%) and TED MOUDIS ASSOCIATES INC (13.13%).

age (WALA) were 4.95% and 75 months as of 04/10/2022, respectively. There are a total of 48 loans and 57 properties in the portfolio. The appraisal LTV was approximately 62.5% compared to the Original loan to value (LTV), which was approximately 64.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.27x. As of 04/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.






Local Distribution





Most recent net operating income debt yield ranged from -4% to 19% with a weighted average NOI debt yield of 8.8%. NOI debt yield ranged from -4% to 19%. There were 2 assets (12% of total balance) with NOI debt yield between -4% and -2%, 2 assets (3% of total balance) with NOI debt yield between 4% and 6%, 4 assets (20% of total balance) with NOI debt yield between 6% and 8%, 11 assets (24% of total balance) with NOI debt yield between 8% and 10%, 8 assets (8% of total balance) with NOI debt yield between 10% and 12%, 12 assets (20% of total balance) with NOI debt yield between 12% and 14%, 4 assets (2% of total balance) with NOI debt yield between 14% and 16%, 4 assets (10% of total balance) with NOI debt yield between 16% and 18%, 1 assets (0% of total balance) with NOI debt yield between 18% and 20%

There were 2 assets (12.3% of total balance) with NCF DSCR between -0.5x and 0.0x, 4 assets (5.7% of total balance) with NCF DSCR between 0.5x and 1.0x, 12 assets (32.9% of total balance) with NCF DSCR between 1.0x and 1.5x, 22 assets (32.8% of total balance) with NCF DSCR between 1.5x and 2.0x, 6 assets (6.3% of total balance) with NCF DSCR between 2.0x and 2.5x and 2 assets (10.0% of total balance) with NCF DSCR between 2.5x and 3.0x. The most recent weighted average NCF DSCR was 1.3x.







DSCRs ranged from -0.5x to 3.0x.There are 2 assets (12.3% of total balance) with DSCR between -0.5x and 0.0x, 2 assets (3.9% of total balance) with DSCR between 0.5x and 1.0x, 12 assets (33.1% of total balance) with DSCR between 1.0x and 1.5x, 22 assets (33.5% of total balance) with DSCR between 1.5x and 2.0x, 5 assets (4.9% of total balance) with DSCR between 2.0x and 2.5x and 5 assets (12.4% of total balance) with DSCR between 2.5x and 3.0x. The most recent weighted average DSCR is 1.4x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
