Transaction Summary

The transaction closed on Oct 18 2016 and matures in Nov 2028. The pool's current aggregate principal balance is \$771.9 million compared to \$813.6 million at close.

The largest loan of the pool (8.4%) is secured by Hyatt Regency Jersey City located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 14%. The second largest loan of the pool (7.8%) is secured by Plaza America I & II located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 86%. The major tenants included SOFTWARE AG USA INC (12.05%) and NVR, Inc. (11.88%). The third largest loan of the pool (5.8%) is secured by Easton Town Center - Trust located in metropolitan area. Occupancy at the subject was 91%. The major tenants included AMC 30 (10.28%) and HH Gregg (2.87%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.30% and 68 months as of 04/10/2022, respectively. There are a total of 45 loans and 84 properties in the portfolio. The appraisal LTV was approximately 59.6% compared to the Original loan to value (LTV), which was approximately 60.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.58x. As of 04/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 82%.






Local Distribution



Among assets in the portfolio, there are 7 properties (13% of total balance) located in New Jersey, 3 properties (13% of total balance) in Ohio, 4 properties (10% of total balance) in New York, 18 properties (9% of total balance) in Illinois, 1 property (8% of total balance) in Virginia, 3 properties (7% of total balance) in Florida, 5 properties (7% of total balance) in Michigan and 3 properties (5% of total balance) in Tennessee. 



There were 1 assets (2.7% of total balance) with NCF DSCR between -1.0x and -0.5x, 1 assets (8.4% of total balance) with NCF DSCR between -0.5x and 0.0x, 1 assets (1.1% of total balance) with NCF DSCR between 0.0x and 0.5x, 5 assets (13.2% of total balance) with NCF DSCR between 0.5x and 1.0x, 17 assets (23.3% of total balance) with NCF DSCR between 1.0x and 1.5x, 13 assets (29.9% of total balance) with NCF DSCR between 1.5x and 2.0x, 3 assets (3.7% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (12.8% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (4.9% of total balance) with NCF DSCR between 6.0x and 6.5x. 



DSCRs ranged from -1.0x to 6.5x.There are 1 assets (2.7% of total balance) with DSCR between -1.0x and -0.5x, 1 assets (8.4% of total balance) with DSCR between -0.5x and 0.0x, 4 assets (13.6% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (3.4% of total balance) with DSCR between 0.5x and 1.0x, 11 assets (15.9% of total balance) with DSCR between 1.0x and 1.5x, 18 assets (32.3% of total balance) with DSCR between 1.5x and 2.0x, 3 assets (5.2% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (3.3% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (10.2% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (4.9% of total balance) with DSCR between 6.0x and 6.5x. There are 1 assets (7.6% of total balance) that have maturity dates between 2025/7 and 2025/12, 4 assets (58.1% of total balance) that have maturity dates between 2026/1 and 2026/6, 38 assets (639.7% of total balance) that have maturity dates between 2026/7 and 2026/12 and 2 assets (66.4% of total balance) that have maturity dates between 2028/7 and 2028/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
