Transaction Summary

The transaction closed on Oct 31 2017 and matures in Oct 2032. The pool's current aggregate principal balance is \$962.3 million compared to \$977.6 million at close.

The largest loan of the pool (7.8%) is secured by South Station located in Boston, MA metropolitan area. Occupancy at the subject was 96%. The major tenants included AMTRAK (21.03%) and COMMONWEALTH OF MASS (19.87%). The second largest loan of the pool (5.2%) is secured by Station Place III located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 100%. The major tenants included United States Government (40.48%) and Kaiser Foundation Health Plan (39.96%). The third largest loan of the pool (4.7%) is secured by Godfrey Hotel located in metropolitan area. Occupancy at the subject was 95%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.46% and 37 months as of 10/12/2020, respectively. There are a total of 57 loans and 95 properties in the portfolio. The appraisal LTV was approximately 58.3% compared to the Original loan to value (LTV), which was approximately 59.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.03x. As of 10/12/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 94%.



Type Concentration







Among assets in the portfolio, there are 12 properties (21% of total balance) located in California, 17 properties (11% of total balance) in New York, 5 properties (10% of total balance) in Massachusetts, 4 properties (5% of total balance) in Nevada, 1 property (5% of total balance) in Washington DC, 9 properties (5% of total balance) in Georgia, 1 property (5% of total balance) in Illinois, 1 property (4% of total balance) in Wisconsin, 1 property (4% of total balance) in Kentucky and 3 properties (4% of total balance) in Florida. Other properties are located in the state of Kentucky, Florida, Kansas, Pennsylvania, Texas, Louisiana, Colorado, Virginia, Delaware, North Carolina, Washington, South Carolina, Missouri, Utah, Virginia, Maryland, Michigan, Ohio, West Connecticut, Maine, New Hampshire, New Jersey and Iowa.

Among all the assets in the portfolio, 1 assets (1% of total balance) had LTVs between 30% and 40%, 8 assets (22% of total balance) with LTVs between 40% and 50%, 20 assets (38% of total balance) with LTVs between 50% and 60%, 24 assets (32% of total balance) with LTVs between 60% and 70% and 4 assets (6% of total balance) with LTVs between 70% and 80%.





NCF DSCR







DSCRs ranged from 0.5x to 5.0x. There are 1 assets (2.4% of total balance) with DSCR between 0.5x and 1.0x, 8 assets (10.7% of total balance) with DSCR between 1.0x and 1.5x, 23 assets (33.8% of total balance) with DSCR between 1.5x and 2.0x, 14 assets (28.3% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (9.8% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (9.8% of total balance) with DSCR between 2.0x and 3.5x, 1 assets (4.0% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (0.7% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (0.7% of total balance) with DSCR between 4.5x and 5.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
