Transaction Summary

The transaction closed on Oct 31 2017 and matures in Oct 2032. The pool's current aggregate principal balance is \$929.8 million compared to \$954.9 million at close.

The largest loan of the pool (8.1%) is secured by South Station located in Boston, MA metropolitan area. Occupancy at the subject was 96%. The major tenants included COMMONWEALTH OF MASSACHUSETTS (19.90%) and CVS (12.98%). The second largest loan of the pool (5.4%) is secured by Station Place III located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 100%. The major tenants included United States Government (40.48%) and Kaiser Foundation Health Plan (39.96%). The third largest loan of the pool (4.8%) is secured by Godfrey Hotel located in metropolitan area. Occupancy at the subject was 51%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.47% and 54 months as of 03/12/2022, respectively. There are a total of 56 loans and 93 properties in the portfolio. The appraisal LTV was approximately 58.6% compared to the Original loan to value (LTV), which was approximately 59.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.49x. As of 03/12/2022, 1.95% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 84%.









Other properties are located in the state of Kentucky, Florida, Kansas, Pennsylvania, Texas, Louisiana, Virginia, Colorado, Delaware, North Carolina, Washington, South Carolina, Missouri, Utah, Virginia, Maryland, Michigan, Ohio, Connecticut, Maine, New Hampshire, New Jersey and Iowa.





There were 1 assets (4.8% of total balance) with NCF DSCR between -1.0x and -0.5x, 1 assets (4.1% of total balance) with NCF DSCR between -0.5x and 0.0x, 3 assets (4.6% of total balance) with NCF DSCR between 0.0x and 0.5x, 5 assets (9.5% of total balance) with NCF DSCR between 0.5x and 1.0x, 15 assets (22.8% of total balance) with NCF DSCR between 1.0x and 1.5x, 13 assets (24.9% of total balance) with NCF DSCR between 1.5x and 2.0x, 9 assets (9.2% of total balance) with NCF DSCR between 2.0x and 2.5x, 5 assets (7.0% of total balance) with NCF DSCR between 2.5x and 3.0x and 4 assets (13.1% of total balance) with NCF DSCR between 3.0x and 3.5x. 



There are 2 assets (9.0% of total balance) with DSCR between -0.5x and 0.0x, 2 assets (3.8% of total balance) with DSCR between 0.0x and 0.5x, 4 assets (7.8% of total balance) with DSCR between 0.5x and 1.0x, 11 assets (14.6% of total balance) with DSCR between 1.0x and 1.5x, 19 assets (35.6% of total balance) with DSCR between 1.5x and 2.0x, 8 assets (8.9% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (6.7% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (10.2% of total balance) with DSCR between 3.0x and 3.5x and 2 assets (3.5% of total balance) with DSCR between 3.5x and 4.0x. There are 7 assets (103.7% of total balance) that have maturity dates between 2022/7 and 2022/12, 4 assets (72.8% of total balance) that have maturity dates between 2027/1 and 2027/6, 42 assets (726.2% of total balance) that have maturity dates between 2027/7 and 2027/12, 2 assets (26.1% of total balance) that have maturity dates between 2031/7 and 2031/12 and 1 assets (1.0% of total balance) that have maturity dates between 2032/7 and 2032/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
