Transaction Summary

The transaction closed on Sep 29 2017 and matures in Jul 2029. The pool's current aggregate principal balance is \$1058.7 million compared to \$1087.4 million at close.

The largest loan of the pool (5.7%) is secured by 225 & 233 Park Avenue South located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included Facebook (39.43%) and BuzzFeed Inc. (28.73%). The second largest loan of the pool (5.2%) is secured by General Motors Building - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 89%. The major tenants included Weil, Gotshal & Manges (24.62%) and Aramis (15.07%). The third largest loan of the pool (5.2%) is secured by 9-19 9th Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The largest tenant was Restoration Hardware (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.28% and 55 months as of 03/15/2022, respectively. There are a total of 53 loans and 167 properties in the portfolio. The appraisal LTV was approximately 55.5% compared to the Original loan to value (LTV), which was approximately 56.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.05x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.

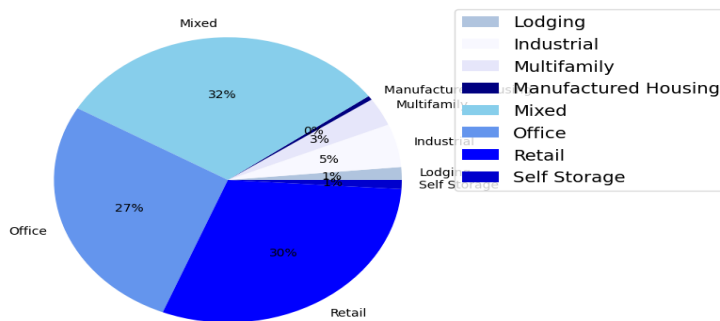

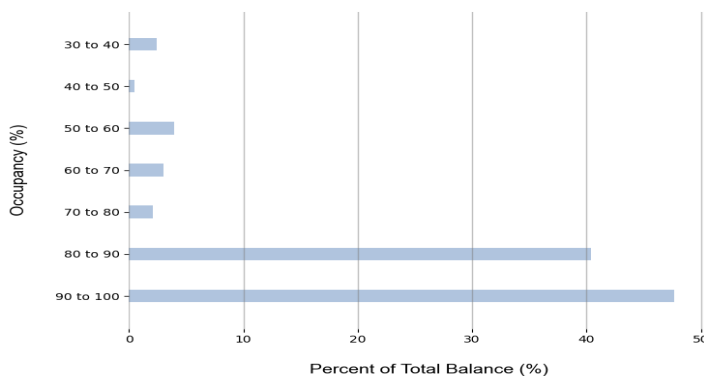

Occupancy Distribution (%)

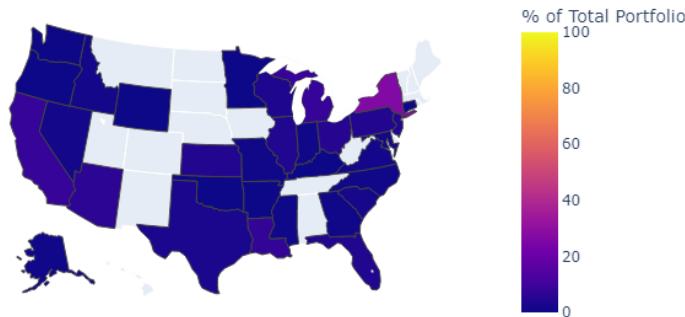

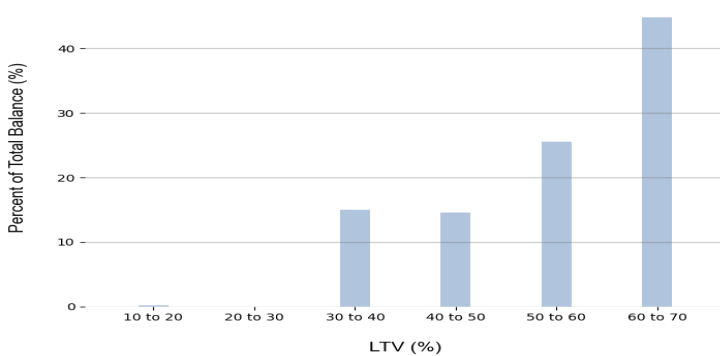
Local Distribution

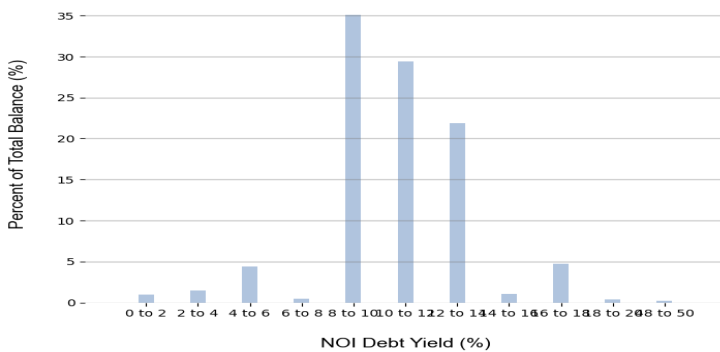

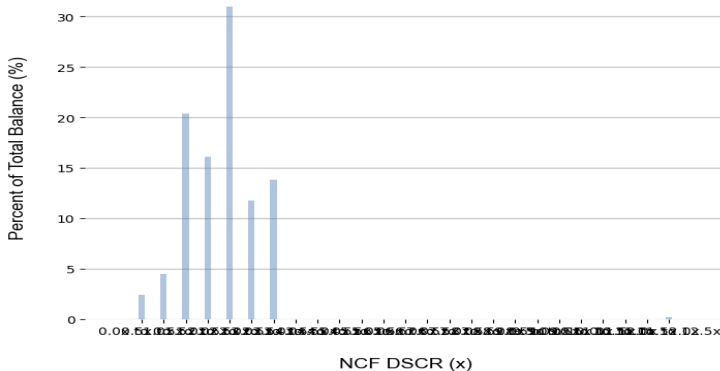
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

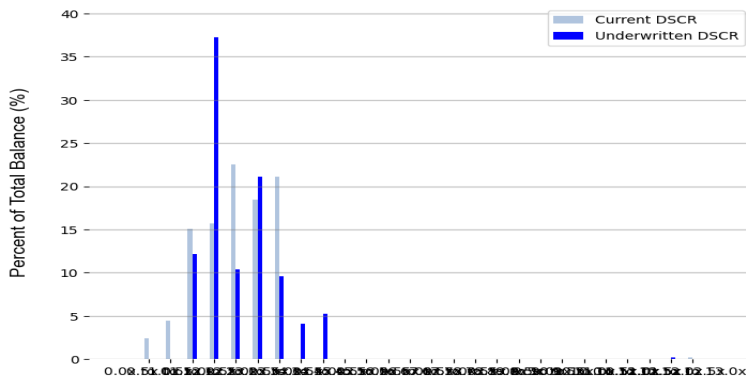


NCF DSCR ranged from 0.0x to 12.5x. There were 2 assets (2.4% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (4.4% of total balance) with NCF DSCR between 0.5x and 1.0x, 13 assets (20.4% of total balance) with NCF DSCR between 1.0x and 1.5x, 10 assets (16.1% of total balance) with NCF DSCR between 1.5x and 2.0x, 14 assets (30.9% of total balance) with NCF DSCR between 2.0x and 2.5x, 5 assets (11.8% of total balance) with NCF DSCR between 2.5x and 3.0x, 6 assets (13.8% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (0.2% of total balance) with NCF DSCR between 12.0x and 12.5x. 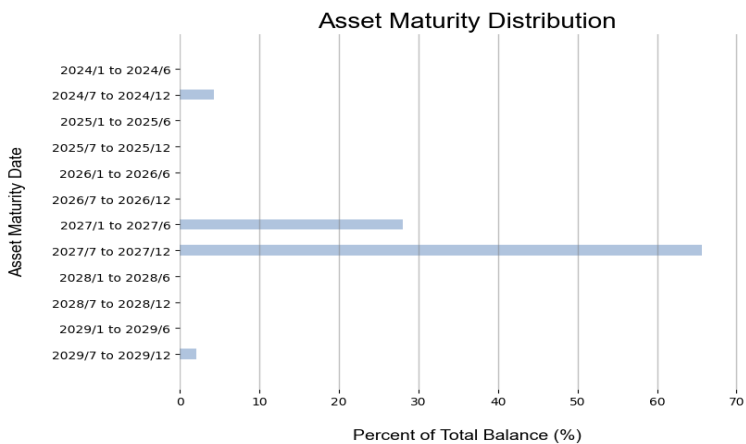

DSCRs ranged from 0.0x to 13.0x. There are 2 assets (2.4% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (4.4% of total balance) with DSCR between 0.5x and 1.0x, 11 assets (15.1% of total balance) with DSCR between 1.0x and 1.5x, 9 assets (15.7% of total balance) with DSCR between 1.5x and 2.0x, 11 assets (22.6% of total balance) with DSCR between 2.0x and 2.5x, 8 assets (18.4% of total balance) with DSCR between 2.5x and 3.0x, 9 assets (21.1% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (0.2% of total balance) with DSCR between 12.5x and 13.0x. The most recent weighted average DSCR is 2.2x.

There are 1 assets (45.1% of total balance) that have maturity dates between 2024/7 and 2024/12, 12 assets (296.4% of total balance) that have maturity dates between 2027/1 and 2027/6, 39 assets (694.6% of total balance) that have maturity dates between 2027/7 and 2027/12 and 1 assets (22.6% of total balance) that have maturity dates between 2029/7 and 2029/12.

EJR used the capitalization rates ("cap rates") listed below for the different types of the properties and then calculated the value of the properties in the portfolio by considering the most recent NCF and the various cap rates.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

1. The symbol in the rating scale used to denote the credit rating categories and notches within categories and the identity of the obligor, security, or money market instrument as required by Paragraph (a)(1)(ii)(A) of Rule 17g-7:

There are three notches in each of EJR's rating categories (e.g., A-(sf), A(sf) and A+(sf) for category A(sf)) except for AAA(sf), CC(sf), C(sf) and D(sf).

2. The version of the procedure or methodology used to determine the credit rating as required by Paragraph (a)(1)(ii)(B) of Rule 17g-7:

We are using the Methodology for Rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) v1b and General Methodology for Rating Asset Backed and Structured Finance Obligations (Non-NRSRO) v2.

3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:

- 1). Are not intended to address the value, price, price stability, liquidity, suitability, or merit of an investment.
- 2). Do not address whether a particular rated security is suitable for a particular investor or suitable for an investor's risk tolerance.
- 3). Do not address whether the expected return of a particular investment is adequate for the inherent risk.


