Transaction Summary

The transaction closed on Jun 21 2018 and matures in Jun 2029. The pool's current aggregate principal balance is \$601.4 million compared to \$609.4 million at close.

The largest loan of the pool (10.8%) is secured by 636 11th Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The largest tenant was The Ogilvy Group Inc. (100.00%). The second largest loan of the pool (10.0%) is secured by 65 Bay Street - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 95%. The major tenants included CVS (0.00%) and CycleBar (0.00%). The third largest loan of the pool (6.2%) is secured by DreamWorks Campus - Trust located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 100%. The largest tenant was DreamWorks (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.70% and 48 months as of 04/10/2022, respectively. There are a total of 39 loans and 44 properties in the portfolio. The appraisal LTV was approximately 54.3% compared to the Original loan to value (LTV), which was approximately 56.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.95x. As of 04/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.





Occupancy Distribution (%)




Local Distribution







EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
