Transaction Summary

The transaction closed on Dec 11 2018 and matures in Nov 2028. The pool's current aggregate principal balance is \$727.2 million compared to \$736.7 million at close.

The largest loan of the pool (9.6%) is secured by DUMBO Heights Portfolio - Trust located in New York-Jersey City-White Plains, NY-NJ-100.00% metropolitan area. Occupancy at the subject was 94%. The major tenants included Etsy (29.90%) and WeWork (21.24%). The second largest loan of the pool (7.3%) is secured by Liberty Portfolio located in metropolitan area. Occupancy at the subject was 100%. The major tenants included Centene Corporation (38.97%) and The Vanguard Group Inc. (15.31%). The third largest loan of the pool (6.0%) is secured by Cambridge Corporate Center located in metropolitan area. Occupancy at the subject was 75%. The major tenants included Red Ventures LLC (27.90%) and General Motors (27.24%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.08% and 41 months as of 03/10/2022, respectively. There are a total of 35 loans and 58 properties in the portfolio. The appraisal LTV was approximately 58.7% compared to the Original loan to value (LTV), which was approximately 58.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.72x. As of 03/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 83%.





Occupancy Distribution (%)





Local Distribution









There are 1 assets (3.7% of total balance) with DSCR between -1.0x and -0.5x, 1 assets (0.5% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (3.5% of total balance) with DSCR between 0.5x and 1.0x, 10 assets (26.9% of total balance) with DSCR between 1.0x and 1.5x, 11 assets (27.3% of total balance) with DSCR between 1.5x and 2.0x, 7 assets (22.3% of total balance) with DSCR between 2.0x and 2.5x, 1 assets (2.7% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (3.4% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (9.6% of total balance) with DSCR between 3.5x and 4.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
