Transaction Summary

The transaction closed on Dec 19 2019 and matures in Jul 2034. The pool's current aggregate principal balance is \$1261.2 million compared to \$1264.2 million at close.

The largest loan of the pool (4.0%) is secured by 490-504 Myrtle Avenue located in New York-Jersey City-White Plains, NY-NJ-100.00% metropolitan area. Occupancy at the subject was 96%. The second largest loan of the pool (4.0%) is secured by 650 Madison Avenue - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 97%. The major tenants included Ralph Lauren Corporation (46.14%) and Memorial Sloan Kettering Cancer Center (16.77%). The third largest loan of the pool (4.0%) is secured by 805 Third Avenue - Pooled located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 92%. The major tenants included Meredith Corporation (35.66%) and Toyota Tsusho America, Inc. (6.93%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.95% and 12 months as of 12/15/2020, respectively. There are a total of 56 loans and 114 properties in the portfolio. The appraisal LTV was approximately 61.7% compared to the Original loan to value (LTV), which was approximately 61.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.68x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.





Occupancy Distribution (%)






Local Distribution



Among assets in the portfolio, there are 18 properties (35% of total balance) located in New York, 7 properties (12% of total balance) in Florida, 9 properties (7% of total balance) in Ohio, 5 properties (6% of total balance) in Texas, 14 properties (5% of total balance) in Michigan, 5 properties (5% of total balance) in New Jersey, 11 properties (5% of total balance) in Pennsylvania and 2 properties (4% of total balance) in California. 



Most recent net operating income debt yield ranged from 0% to 19% with a weighted average NOI debt yield of 8.7%. NOI debt yield ranged from 0% to 19%. There were 1 assets (0% of total balance) with NOI debt yield between 0% and 2%, 2 assets (3% of total balance) with NOI debt yield between 4% and 6%, 20 assets (40% of total balance) with NOI debt yield between 6% and 8%, 19 assets (35% of total balance) with NOI debt yield between 8% and 10%, 6 assets (11% of total balance) with NOI debt yield between 10% and 12%, 3 assets (7% of total balance) with NOI debt yield between 12% and 14%, 4 assets (3% of total balance) with NOI debt yield between 14% and 16%, 1 assets (1% of total balance) with NOI debt yield between 18% and 20%

NCF DSCR ranged from 0.0x to 3.0x. There were 55 assets (99.2% of total balance) with NCF DSCR between 0.0x and 0.5x and 1 assets (0.8% of total balance) with NCF DSCR between 2.5x and 3.0x. The most recent weighted average NCF DSCR was 2.7x.




DSCR (Current / Underwritten)



EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
