Transaction Summary

The transaction closed on Dec 19 2019 and matures in Jul 2034. The pool's current aggregate principal balance is \$1256.4 million compared to \$1264.2 million at close.

The largest loan of the pool (4.0%) is secured by 490-504 Myrtle Avenue located in New York-Jersey City-White Plains, NY-NJ-100.00% metropolitan area. Occupancy at the subject was 77%. The second largest loan of the pool (4.0%) is secured by 650 Madison Avenue - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 97%. The major tenants included Ralph Lauren Corporation (46.14%) and Memorial Sloan Kettering Cancer Center (16.77%). The third largest loan of the pool (4.0%) is secured by 805 Third Avenue - Pooled located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 81%. The major tenants included Meredith Corporation (35.66%) and Toyota Tsusho America, Inc. (6.93%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.95% and 28 months as of 04/15/2022, respectively. There are a total of 56 loans and 114 properties in the portfolio. The appraisal LTV was approximately 61.4% compared to the Original loan to value (LTV), which was approximately 61.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.02x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 88%.

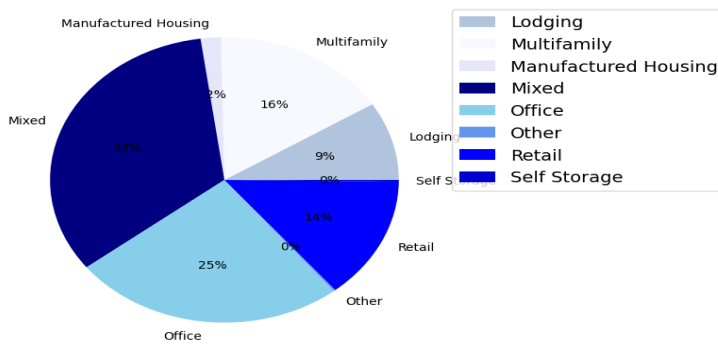

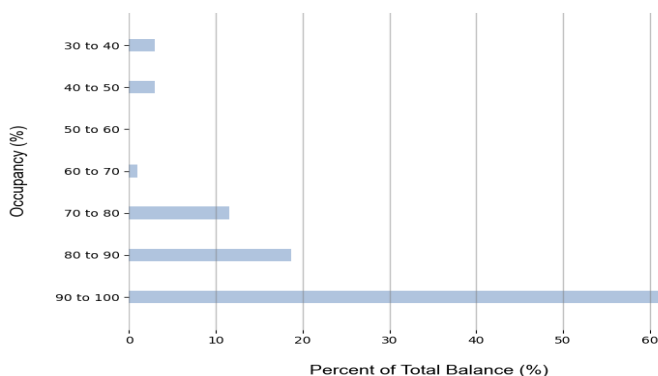

Occupancy Distribution (%)

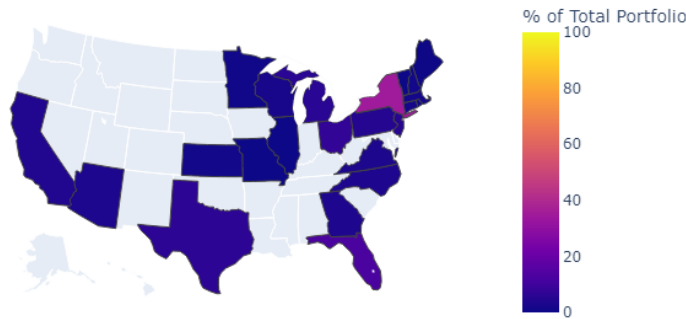

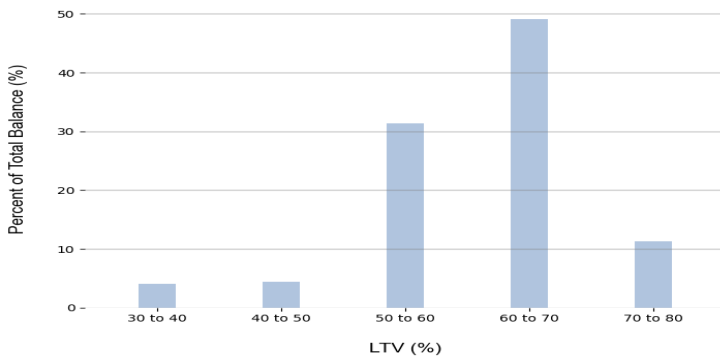
Local Distribution

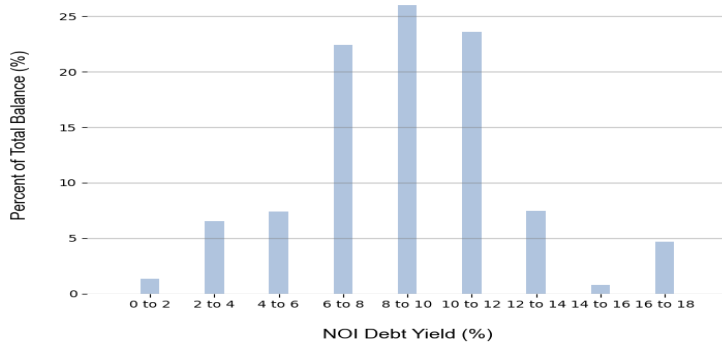

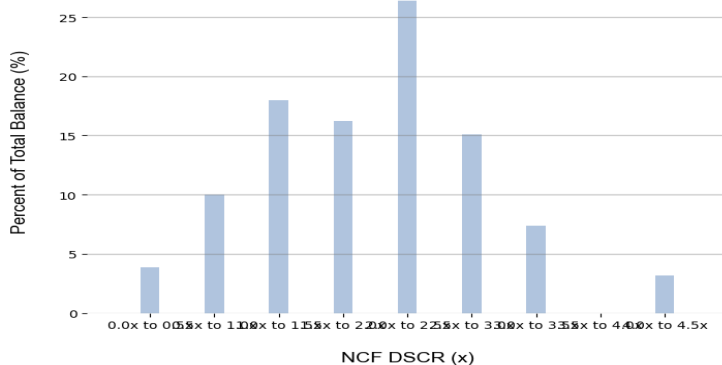
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 0% to 17% with a weighted average NOI debt yield of 8.9%. NOI debt yield ranged from 0% to 17%. Net Cash Flow DSCR (x)

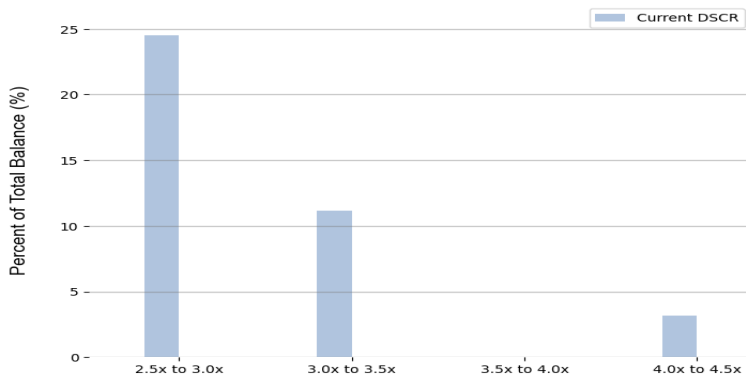


NCF DSCR ranged from 0.0x to 4.5x. There were 5 assets (3.8% of total balance) with NCF DSCR between 0.0x and 0.5x, 4 assets (10.0% of total balance) with NCF DSCR between 0.5x and 1.0x, 6 assets (18.0% of total balance) with NCF DSCR between 1.0x and 1.5x, 15 assets (16.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 14 assets (26.4% of total balance) with NCF DSCR between 2.0x and 2.5x, 9 assets (15.1% of total balance) with NCF DSCR between 2.5x and 3.0x, 2 assets (7.4% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (3.2% of total balance) with NCF DSCR between 4.0x and 4.5x. 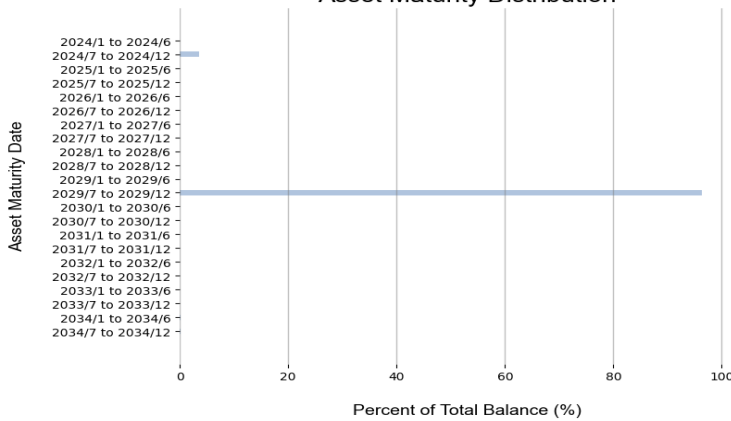
DSCR Distribution (x)



DSCRs ranged from 2.5x to 4.5x. There are 13 assets (24.5% of total balance) with DSCR between 2.5x and 3.0x, 4 assets (11.1% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (3.2% of total balance) with DSCR between 4.0x and 4.5x. The most recent weighted average DSCR is 2.2x. Underwritten DSCR is not available.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

Appendix I

Smoothing Calculation
