Transaction Summary

The transaction closed on Aug 20 2019 and matures in Aug 2034. The pool's current aggregate principal balance is \$1274.4 million compared to \$1276.7 million at close.

The largest loan of the pool (7.8%) is secured by 30 Hudson Yards - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The largest tenant was WarnerMedia (100.00%). The second largest loan of the pool (5.5%) is secured by Millennium Park Plaza located in metropolitan area. Occupancy at the subject was 99%. The major tenants included Residential (80.97%) and CENTURYLINKINC (1.64%). The third largest loan of the pool (4.9%) is secured by USAA Office Portfolio located in Dallas-Plano-Irving, TX-47.36% metropolitan area. Occupancy at the subject was 100%. The largest tenant was USAA (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.86% and 15 months as of 10/10/2020, respectively. There are a total of 43 loans and 101 properties in the portfolio. The appraisal LTV was approximately 58.4% compared to the Original loan to value (LTV), which was approximately 58.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.32x. As of 10/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 93%.





Occupancy Distribution (%)




Local Distribution





There were 2 assets (1% of total balance) with NOI debt yield between 2% and 4%, 4 assets (8% of total balance) with NOI debt yield between 4% and 6%, 9 assets (21% of total balance) with NOI debt yield between 6% and 8%, 13 assets (39% of total balance) with NOI debt yield between 8% and 10%, 7 assets (13% of total balance) with NOI debt yield between 10% and 12%, 4 assets (10% of total balance) with NOI debt yield between 12% and 14%, 3 assets (6% of total balance) with NOI debt yield between 16% and 18%, 1 assets (1% of total balance) with NOI debt yield between 18% and 20%

There were 11 assets (23.4% of total balance) with NCF DSCR between 0.0x and 0.5x, 1 assets (0.8% of total balance) with NCF DSCR between 0.5x and 1.0x, 5 assets (7.9% of total balance) with NCF DSCR between 1.0x and 1.5x, 11 assets (20.7% of total balance) with NCF DSCR between 1.5x and 2.0x, 10 assets (25.5% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (13.2% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (3.7% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (4.7% of total balance) with NCF DSCR between 4.5x and 5.0x. 



There are 11 assets (23.4% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (0.8% of total balance) with DSCR between 0.5x and 1.0x, 4 assets (7.5% of total balance) with DSCR between 1.0x and 1.5x, 10 assets (19.0% of total balance) with DSCR between 1.5x and 2.0x, 9 assets (22.3% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (14.6% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (7.7% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (4.7% of total balance) with DSCR between 5.0x and 5.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
