Transaction Summary

The transaction closed on Nov 13 2019 and matures in Nov 2029. The pool's current aggregate principal balance is \$935.8 million compared to \$937.0 million at close.

The largest loan of the pool (9.0%) is secured by 30 Hudson Yards - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The largest tenant was WarnerMedia (100.00%). The second largest loan of the pool (8.3%) is secured by Kawa Mixed-Use Portfolio II located in Dallas-Plano-Irving, TX-28.08% Cambridge-Newton-Framingham, MA-23.46% metropolitan area. Occupancy at the subject was 100%. The major tenants included L3 Technologies (31.86%) and Arrow Electronics (29.25%). The third largest loan of the pool (8.3%) is secured by California Office Portfolio located in Anaheim-Santa Ana-Irvine, CA-49.17% metropolitan area. Occupancy at the subject was 100%. The major tenants included Marvell Semiconductor Inc. (51.10%) and Ambry Genetics (27.41%).

age (WALA) were 3.64% and 13 months as of 10/10/2020, respectively. There are a total of 34 loans and 75 properties in the portfolio. The appraisal LTV was approximately 61.5% compared to the Original loan to value (LTV), which was approximately 61.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.42x. As of 10/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 95%.





Occupancy Distribution (%)




Local Distribution




NOI Debt Yield (%)


DSCR (Current / Underwritten)



EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
