Transaction Summary

The transaction closed on Feb 26 2015 and matures in Jan 2035. The pool's current aggregate principal balance is \$823.0 million compared to \$866.7 million at close.

The largest loan of the pool (7.6%) is secured by Westfield Palm Desert located in metropolitan area. Occupancy at the subject was 93%. The major tenants included Macy's (44.31%) and JC Penney (14.83%). The second largest loan of the pool (7.3%) is secured by 555 11th Street NW - Pooled located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 99%. The major tenants included Latham (58.09%) and Landmark Theaters (9.66%). The third largest loan of the pool (3.6%) is secured by 555 11th Street NW - NonPooled located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 99%. The major tenants included Latham (58.09%) and Landmark Theaters (9.66%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.13% and 71 months as of 12/15/2020, respectively. There are a total of 63 loans and 84 properties in the portfolio. The appraisal LTV was approximately 59.9% compared to the Original loan to value (LTV), which was approximately 61.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.39x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 6% to 41% with a weighted average NOI debt yield of 14.6%. NOI debt yield ranged from 6% to 41%. There were 2 assets (3.2% of total balance) with NCF DSCR between 0.5x and 1.0x, 14 assets (17.6% of total balance) with NCF DSCR between 1.0x and 1.5x, 25 assets (30.4% of total balance) with NCF DSCR between 1.5x and 2.0x. 11 assets (22.9% of total balance) with NCF DSCR between 2.0x and 2.5x, 4 assets (5.5% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (0.3% of total balance) with NCF DSCR between 3.0x and 3.5x, 3 assets (8.3% of total balance) with NCF DSCR between 3.5x and 4.0x, 2 assets (10.9% of total balance) with NCF DSCR between 4.5x and 5.0x and 1 assets (0.8% of total balance) with NCF DSCR between 6.0x and 6.5x. 



There are 12 assets (11.1% of total balance) with DSCR between 1.0x and 1.5x, 20 assets (27.7% of total balance) with DSCR between 1.5x and 2.0x, 18 assets (24.8% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (16.1% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (0.3% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (7.2% of total balance) with DSCR between 3.5x and 4.0x, 2 assets (1.2% of total balance) with DSCR between 4.0x and 4.5x, 2 assets (10.9% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (0.8% of total balance) with DSCR between 6.5x and 7.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
