Transaction Summary

The transaction closed on Jun 18 2015 and matures in May 2045. The pool's current aggregate principal balance is \$891.5 million compared to \$941.9 million at close.

The largest loan of the pool (8.9%) is secured by TKG 3 Retail Portfolio located in metropolitan area. Occupancy at the subject was 97%. The major tenants included Walmart (14.42%) and Lowe's Home Improvement (9.18%). The second largest loan of the pool (7.4%) is secured by 32 Old Slip Fee located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The largest tenant was RXR Old Slip Owner LLC (100.00%). The third largest loan of the pool (6.3%) is secured by Fairfax Corner located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 94%. The major tenants included REI (12.52%) and ARHAUS FURNITURE (8.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.16% and 67 months as of 12/15/2020, respectively. There are a total of 67 loans and 76 properties in the portfolio. The appraisal LTV was approximately 65.6% compared to the Original loan to value (LTV), which was approximately 68.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.82x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 93%.








Local Distribution





Most recent net operating income debt yield ranged from 4% to 29% with a weighted average NOI debt yield of 10.7%. NOI debt yield ranged from 4% to 29%. There were 1 assets (7% of total balance) with NOI debt yield between 4% and 6%, 2 assets (3% of total balance) with NOI debt yield between 6% and 8%, 18 assets (41% of total balance) with NOI debt yield between 8% and 10%, 21 assets (24% of total balance) with NOI debt yield between 10% and 12%, 14 assets (15% of total balance) with NOI debt yield between 12% and 14%, 5 assets (3% of total balance) with NOI debt yield between 14% and 16%, 1 assets (0% of total balance) with NOI debt yield between 16% and 18%, 4 assets (7% of total balance) with NOI debt yield between 18% and 20%, 1 assets (0% of total balance) with NOI debt yield between 28% and 30%

All assets in the portfolio had net cash flow debt service coverage ratios (NCF DSCR) higher than 1x. NCF DSCR ranged from 1.0x to 4.0x. There were 16 assets (31.4% of total balance) with NCF DSCR between 1.0x and 1.5x, 29 assets (40.7% of total balance) with NCF DSCR between 1.5x and 2.0x, 15 assets (18.5% of total balance) with NCF DSCR between 2.0x and 2.5x, 4 assets (8.0% of total balance) with NCF DSCR between 2.5x and 3.0x, 2 assets (1.1% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (0.4% of total balance) with NCF DSCR between 3.5x and 4.0x. The most recent weighted average NCF DSCR was 1.8x.







DSCRs ranged from 1.0x to 4.5x.There are 11 assets (19.4% of total balance) with DSCR between 1.0x and 1.5x, 27 assets (38.2% of total balance) with DSCR between 1.5x and 2.0x, 19 assets (30.3% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (9.4% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (1.9% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.4% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (0.4% of total balance) with DSCR between 4.0x and 4.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
