## **Transaction Summary**

The transaction closed on Aug 05 2015 and matures in May 2045. The pool's current aggregate principal balance is \$887.2 million compared to \$924.4 million at close.

The largest loan of the pool (12.4%) is secured by 535-545 Fifth Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 80%. The major tenants included 545 5th Avenue NYC LLC Knotel (7.55%) and Best Buy (7.18%). The second largest loan of the pool (9.4%) is secured by Coastal Equities Retail Portfolio located in Detroit-Dearborn-Livonia, MI-8.88% metropolitan area. Occupancy at the subject was 88%. The major tenants included Tractor Supply Company (4.75%) and Ollie's Bargain Outlet (4.67%). The third largest loan of the pool (8.4%) is secured by Serenity Place at Dorsey Ridge located in metropolitan area. Occupancy at the subject was 94%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.37% and 64 months as of 10/15/2020, respectively. There are a total of 73 loans and 129 properties in the portfolio. The appraisal LTV was approximately 65.5% compared to the Original loan to value (LTV), which was approximately 66.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.65x. As of 10/15/2020, 0.68% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 86%.



Type Concentration





#### Occupancy Distribution (%)





Among assets in the portfolio, there are 14 properties (21% of total balance) located in New York, 14 properties (13% of total balance) in Texas, 2 properties (9% of total balance) in Maryland, 6 properties (6% of total balance) in California, 5 properties (6% of total balance) in Michigan, 10 properties (5% of total balance) in North Carolina, 7 properties (5% of total balance) in Pennsylvania, 2 properties (3% of total balance) in Massachusetts and 7 properties (3% of total balance) in Ohio. Other properties are located in the state of Ohio, Florida, Virginia, Georgia, Oregon, Wisconsin, South Carolina, Louisiana, Illinois, Vermont, Tennessee, Nevada, Washington, Indiana, Alabama, Missouri, Delaware, New Jersey, Connecticut, Kentucky and Arkansas.

Among all the assets in the portfolio, 2 assets (1% of total balance) had LTVs between 30% and 40%, 2 assets (13% of total balance) with LTVs between 40% and 50%, 16 assets (10% of total balance) with LTVs between 50% and 60%, 41 assets (48% of total balance) with LTVs between 60% and 70% and 12 assets (28% of total balance) with LTVs between 70% and 80%.





Most recent net operating income debt yield ranged from 4% to 25% with a weighted average NOI debt yield of 9.9%. NOI debt yield ranged from 4% to 25%. There were 5 assets (23% of total balance) with NOI debt yield between 4% and 6%, 5 assets (15% of total balance) with NOI debt yield between 6% and 8%, 11 assets (9% of total balance) with NOI debt yield between 8% and 10%, 17 assets (23% of total balance) with NOI debt yield between 10% and 12%, 16 assets (15% of total balance) with NOI debt yield between 12% and 14%, 11 assets (8% of total balance) with NOI debt yield between 14% and 16%, 3 assets (3% of total balance) with NOI debt yield between 16% and 18%, 4 assets (3% of total balance) with NOI debt yield between 18% and 20%, 1 assets (1% of total balance) with NOI debt yield between 24% and 26%

There were 1 assets (0.7% of total balance) with NCF DSCR between 0.0x and 0.5x, 4 assets (16.7% of total balance) with NCF DSCR between 0.5x and 1.0x, 14 assets (26.0% of total balance) with NCF DSCR between 1.0x and 1.5x, 33 assets (35.1% of total balance) with NCF DSCR between 1.5x and 2.0x, 9 assets (10.8% of total balance) with NCF DSCR between 2.0x and 2.5x, 9 assets (8.6% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (1.4% of total balance) with NCF DSCR between 3.0x and 3.5x, 1 assets (0.3% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (0.4% of total balance) with NCF DSCR between 4.0x and 4.5x. 





DSCRs ranged from 0.0x to 4.5x. There are 1 assets (0.7% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (2.4% of total balance) with DSCR between 0.5x and 1.0x, 13 assets (37.6% of total balance) with DSCR between 1.0x and 1.5x, 26 assets (28.2% of total balance) with DSCR between 1.5x and 2.0x, 19 assets (19.2% of total balance) with DSCR between 2.0x and 2.5x, 8 assets (7.7% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (3.6% of total balance) with DSCR between 3.0x and 3.5x and 2 assets (0.7% of total balance) with DSCR between 4.0x and 4.5x. The most recent weighted average DSCR is 1.8x.

There are 1 assets (0.7% of total balance) that have maturity dates between 2020/7 and 2020/12, 25 assets (35.8% of total balance) that have maturity dates between 2025/1 and 2025/6, 46 assets (57.9% of total balance) that have maturity dates between 2025/7 and 2025/12 and 1 assets (5.6% of total balance) that have maturity dates between 2045/1 and 2045/6.

# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.

2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
