# **Transaction Summary**

The transaction closed on Nov 12 2015 and matures in Nov 2030. The pool's current aggregate principal balance is \$980.0 million compared to \$1017.9 million at close.

The largest loan of the pool (11.2%) is secured by 535-545 Fifth Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 80%. The major tenants included 5th Avenue NYC LLC Knotel (7.55%) and Best Buy (7.18%). The second largest loan of the pool (10.2%) is secured by Herald Center located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 97%. The major tenants included ASA COLLEGE INC. (66.45%) and H&M (25.21%). The third largest loan of the pool (9.4%) is secured by 11 Madison Avenue - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 96%. The major tenants included Credit Suisse (55.41%) and Sony (25.33%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.42% and 66 months as of 12/15/2020, respectively. There are a total of 63 loans and 96 properties in the portfolio. The appraisal LTV was approximately 58.2% compared to the Original loan to value (LTV), which was approximately 59.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.03x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.





### Occupancy Distribution (%)




#### Local Distribution





There were 1 assets (0.4% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (12.0% of total balance) with NCF DSCR between 0.5x and 1.0x, 10 assets (20.2% of total balance) with NCF DSCR between 1.0x and 1.5x, 24 assets (25.4% of total balance) with NCF DSCR between 1.5x and 2.0x, 14 assets (24.7% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (3.1% of total balance) with NCF DSCR between 2.5x and 3.0x, 5 assets (3.2% of total balance) with NCF DSCR between 3.0x and 3.5x, 3 assets (10.5% of total balance) with NCF DSCR between 4.0x and 4.5x and 1 assets (0.5% of total balance) with NCF DSCR between 5.0x and 5.5x. 



DSCRs ranged from 0.0x to 5.5x. There are 1 assets (0.4% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (0.8% of total balance) with DSCR between 0.5x and 1.0x, 6 assets (19.7% of total balance) with DSCR between 1.0x and 1.5x, 21 assets (26.9% of total balance) with DSCR between 1.5x and 2.0x, 19 assets (30.7% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (7.4% of total balance) with DSCR between 2.5x and 3.0x, 4 assets (2.8% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.4% of total balance) with DSCR between 3.5x and 4.0x, 3 assets (10.5% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (0.5% of total balance) with DSCR between 5.0x and 5.5x. # EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
