Transaction Summary

The transaction closed on Nov 24 2015 and matures in Sep 2035. The pool's current aggregate principal balance is \$741.2 million compared to \$790.1 million at close.

The largest loan of the pool (12.1%) is secured by 535-545 Fifth Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 80%. The major tenants included 5th Avenue NYC LLC Knotel (7.55%) and Best Buy (7.18%). The second largest loan of the pool (7.4%) is secured by Crowne Plaza - Hollywood, FL located in Fort Lauderdale-Pompano Beach-Deerfield Beach, FL metropolitan area. Occupancy at the subject was 71%. The third largest loan of the pool (7.1%) is secured by Hotel Valencia Santana Row located in metropolitan area. Occupancy at the subject was 83%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.54% and 65 months as of 01/15/2021, respectively. There are a total of 53 loans and 165 properties in the portfolio. The appraisal LTV was approximately 61.9% compared to the Original loan to value (LTV), which was approximately 61.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.73x. As of 01/15/2021, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.



Type Concentration









Among assets in the portfolio, there are 9 properties (17% of total balance) located in New York, 19 properties (17% of total balance) in Texas, 16 properties (13% of total balance) in California, 7 properties (9% of total balance) in Florida, 5 properties (6% of total balance) in Louisiana, 5 properties (4% of total balance) in Georgia, 12 properties (3% of total balance) in Ohio and 2 properties (3% of total balance) in Iowa. Other properties are located in the state of North Carolina, Virginia, Indiana, Pennsylvania, Michigan, Arkansas, Wisconsin, Arizona, Missouri, Colorado, New Jersey, Illinois, Maryland, Oklahoma, Connecticut, Alabama, Tennessee, Oregon, Minnesota, Kansas, Kentucky, Massachusetts, Delaware, South Carolina, New Hampshire, Washington, Idaho, Maine, Rhode Island, Mississippi and Utah.

Among all the assets in the portfolio, 1 assets (4% of total balance) had LTVs between 10% and 20%, 6 assets (23% of total balance) with LTVs between 40% and 50%, 15 assets (16% of total balance) with LTVs between 50% and 60%, 22 assets (34% of total balance) with LTVs between 60% and 70% and 9 assets (23% of total balance) with LTVs between 70% and 80%.





Most recent net operating income debt yield ranged from 2% to 37% with a weighted average NOI debt yield of 11.1%. NOI debt yield ranged from 2% to 37%. There were 4 assets (17.3% of total balance) with NCF DSCR between 0.5x and 1.0x, 13 assets (22.2% of total balance) with NCF DSCR between 1.0x and 1.5x, 17 assets (34.1% of total balance) with NCF DSCR between 1.5x and 2.0x, 7 assets (9.8% of total balance) with NCF DSCR between 2.0x and 2.5x, 6 assets (11.8% of total balance) with NCF DSCR between 2.5x and 3.0x, 5 assets (4.5% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (0.4% of total balance) with NCF DSCR between 4.0x and 4.5x. The most recent weighted average NCF DSCR was 1.7x.







DSCRs ranged from 0.5x to 4.5x. There are 2 assets (4.4% of total balance) with DSCR between 0.5x and 1.0x, 10 assets (29.1% of total balance) with DSCR between 1.0x and 1.5x, 20 assets (37.6% of total balance) with DSCR between 1.5x and 2.0x, 7 assets (11.6% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (5.1% of total balance) with DSCR between 2.0x and 2.5x, and 3.0x, 7 assets (11.9% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (0.4% of total balance) with DSCR between 4.0x and 4.5x. The most recent weighted average DSCR is 1.9x.

There are 1 assets (5.4% of total balance) that have maturity dates between 2024/1 and 2024/6, 1 assets (12.1% of total balance) that have maturity dates between 2025/1 and 2025/6, 49 assets (78.5% of total balance) that have maturity dates between 2025/7 and 2025/12, 1 assets (0.4% of total balance) that have maturity dates between 2030/7 and 2030/12 and 1 assets (3.5% of total balance) that have maturity dates between 2035/7 and 2035/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
