Transaction Summary

The transaction closed on May 05 2016 and matures in May 2026. The pool's current aggregate principal balance is \$1040.0 million compared to \$1070.7 million at close.

The largest loan of the pool (5.4%) is secured by Grove City Premium Outlets located in metropolitan area. Occupancy at the subject was 82%. The major tenants included Vanity Fair (4.97%) and Old Navy (3.78%). The second largest loan of the pool (4.8%) is secured by 300 Four Falls located in Montgomery County-Bucks County-Chester County, PA metropolitan area. Occupancy at the subject was 90%. The major tenants included John Templeton Foundation (19.55%) and Tandigm Health LLC (12.01%). The third largest loan of the pool (29.8%) is secured by Penn Square Mall located in metropolitan area. Occupancy at the subject was 97%. The major tenants included Dillard's (28.54%) and Macy's (15.06%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.53% and 58 months as of 12/15/2020, respectively. There are a total of 68 loans and 105 properties in the portfolio. The appraisal LTV was approximately 59.0% compared to the Original loan to value (LTV), which was approximately 59.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.13x. As of 12/15/2020, 1.58% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.

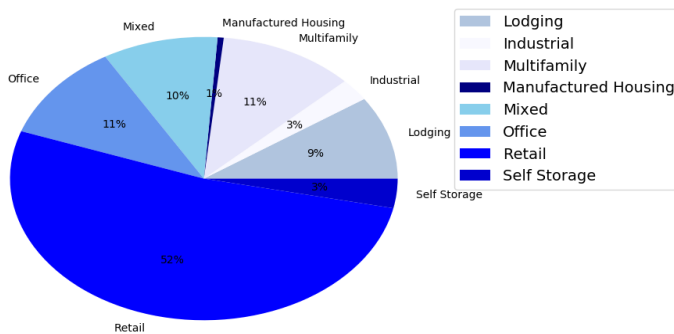

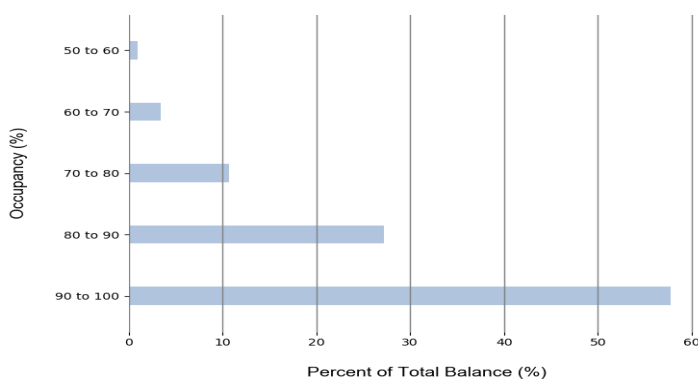

Occupancy Distribution (%)

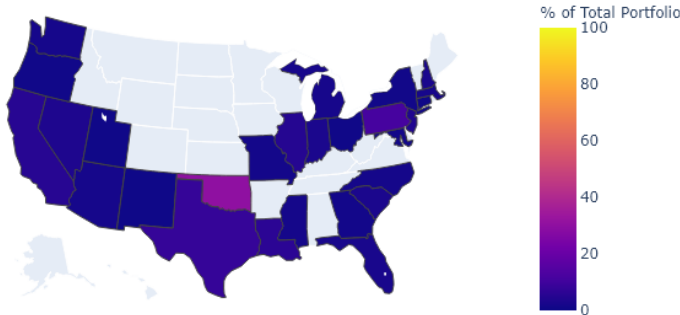

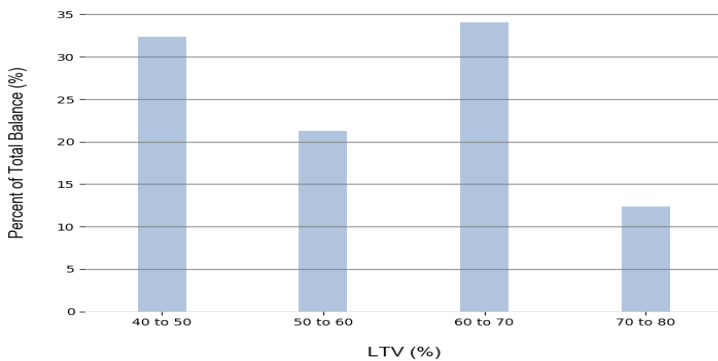
Local Distribution

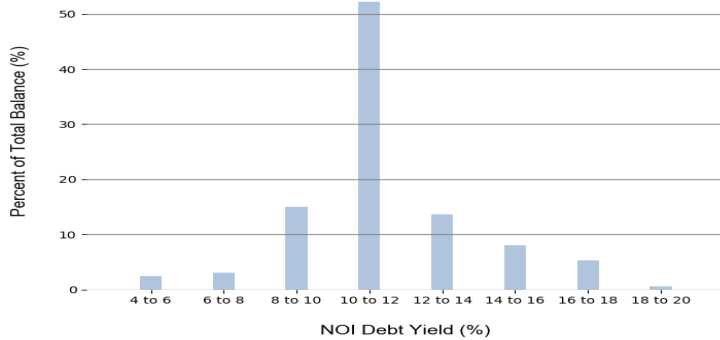

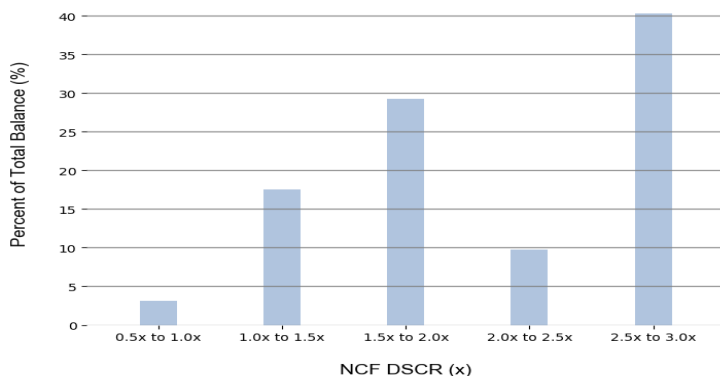
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 4% to 19% with a weighted average NOI debt yield of 11.4%. NOI debt yield ranged from 4% to 19%. There were 2 assets (2% of total balance) with NOI debt yield between 4% and 6%, 4 assets (3% of total balance) with NOI debt yield between 6% and 8%, 10 assets (15% of total balance) with NOI debt yield between 8% and 10%, 23 assets (52% of total balance) with NOI debt yield between 10% and 12%, 17 assets (14% of total balance) with NOI debt yield between 12% and 14%, 8 assets (8% of total balance) with NOI debt yield between 14% and 16%, 3 assets (5% of total balance) with NOI debt yield between 16% and 18% and 1 assets (1% of total balance) with NOI debt yield between 18% and 20%.

Net Cash Flow DSCR (x)

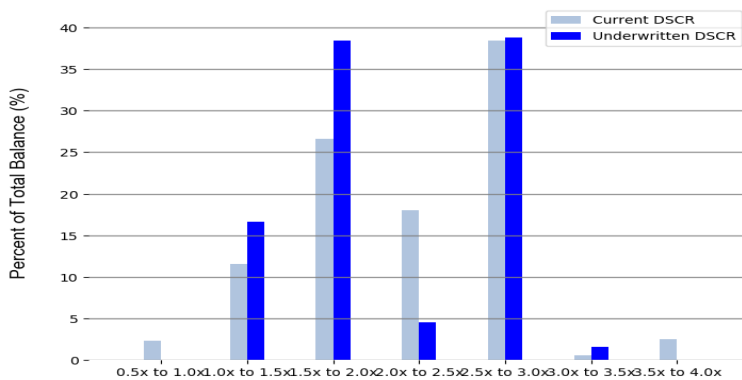


NCF DSCR ranged from 0.0x to 3.0x. There were 3 assets (3.1% of total balance) with NCF DSCR between 0.5x and 1.0x, 19 assets (17.5% of total balance) with NCF DSCR between 1.0x and 1.5x, 29 assets (29.3% of total balance) with NCF DSCR between 1.5x and 2.0x, 11 assets (9.7% of total balance) with NCF DSCR between 2.0x and 2.5x and 6 assets (40.4% of total balance) with NCF DSCR between 2.5x and 3.0x. 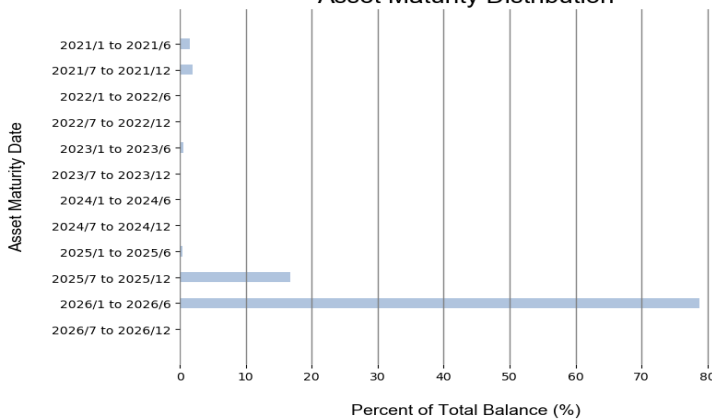
DSCR Distribution (x)



DSCRs ranged from 0.5x to 4.0x. There are 2 assets (2.4% of total balance) with DSCR between 0.5x and 1.0x, 13 assets (11.5% of total balance) with DSCR between 1.0x and 1.5x, 27 assets (26.6% of total balance) with DSCR between 1.5x and 2.0x, 18 assets (18.1% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (38.4% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (0.6% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (2.5% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 2.3x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
