### **Transaction Summary**

The transaction closed on May 05 2016 and matures in May 2026. The pool's current aggregate principal balance is \$978.5 million compared to \$1018.8 million at close.

The largest loan of the pool (5.7%) is secured by Grove City Premium Outlets located in metropolitan area. Occupancy at the subject was 77%. The major tenants included Lee Wrangler Clearance (4.97%) and Old Navy (3.78%). The second largest loan of the pool (5.1%) is secured by 300 Four Falls located in Montgomery County-Bucks County-Chester County, PA metropolitan area. Occupancy at the subject was 84%. The major tenants included Tandigm Health LLC (12.01%) and John Templeton Foundation (11.29%). The third largest loan of the pool (31.7%) is secured by Penn Square Mall located in metropolitan area. Occupancy at the subject was 92%. The major tenants included Dillard's (28.54%) and Macy's (15.06%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.51% and 74 months as of 04/15/2022, respectively. There are a total of 63 loans and 99 properties in the portfolio. The appraisal LTV was approximately 58.8% compared to the Original loan to value (LTV), which was approximately 58.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.86x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 85%.



Type Concentration









Among assets in the portfolio, there are 1 property (32% of total balance) located in Oklahoma, 9 properties (12% of total balance) in % of Total Portfolio Pennsylvania, 11 properties (8% of total balance) in Texas, 7 properties (5% of total balance) in California, 5 properties (5% of total balance) in Louisiana, 21 properties (5% of total balance) in Illinois, 3 properties (4% of total balance) in New Jersey and 2 properties (3% of total balance) in Nevada. 



NOI Debt Yield (%)







Most recent net operating income debt yield ranged from -2% to 19% with a weighted average NOI debt yield of 10.1%. NOI debt yield ranged from -2% to 19%. There were 1 assets (2.7% of total balance) with NCF DSCR between -0.5x and 0.0x, 4 assets (3.9% of total balance) with NCF DSCR between 0.0x and 0.5x, 5 assets (3.7% of total balance) with NCF DSCR between 0.5x and 1.0x, 11 assets (14.5% of total balance) with NCF DSCR between 1.0x and 1.5x, 25 assets (23.5% of total balance) with NCF DSCR between 1.5x and 2.0x, 13 assets (48.0% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (3.0% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (0.6% of total balance) with NCF DSCR between 3.0x and 3.5x. 

DSCRs ranged from 0.0x to 4.0x. There are 4 assets (5.6% of total balance) with DSCR between 0.0x and 0.5x, 6 assets (4.8% of total balance) with DSCR between 0.5x and 1.0x, 5 assets (5.6% of total balance) with DSCR between 1.0x and 1.5x, 28 assets (28.8% of total balance) with DSCR between 1.5x and 2.0x, 11 assets (46.2% of total balance) with DSCR between 2.0x and 2.5x, 8 assets (8.3% of total balance) with DSCR between 2.5x and 3.0x and 1 assets (0.6% of total balance) with DSCR between 3.5x and 4.0x. ## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.
