Transaction Summary

The transaction closed on Sep 29 2016 and matures in Nov 2028. The pool's current aggregate principal balance is \$856.4 million compared to \$884.0 million at close.

The largest loan of the pool (9.0%) is secured by Vertex Pharmaceuticals HQ located in Boston, MA metropolitan area. Occupancy at the subject was 100%. The major tenants included Vertex Pharmaceuticals Inc. (95.47%) and Bright Horizons Centers (1.12%). The second largest loan of the pool (8.8%) is secured by Easton Town Center - Trust located in metropolitan area. Occupancy at the subject was 95%. The major tenants included AMC 30 (10.30%) and H.H. Gregg (2.90%). The third largest loan of the pool (8.2%) is secured by Briarwood Mall located in metropolitan area. Occupancy at the subject was 87%. The major tenants included Forever 21 (4.31%) and Victoria's Secret (3.85%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.13% and 53 months as of 12/15/2020, respectively. There are a total of 47 loans and 57 properties in the portfolio. The appraisal LTV was approximately 55.2% compared to the Original loan to value (LTV), which was approximately 56.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.76x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 4% to 27% with a weighted average NOI debt yield of 13.3%. NOI debt yield ranged from 4% to 27%. There were 2 assets (1% of total balance) with NOI debt yield between 4% and 6%, 2 assets (4% of total balance) with NOI debt yield between 6% and 8%, 6 assets (7% of total balance) with NOI debt vield between 8% and 10%, 17 assets (38% of total balance) with NOI debt yield between 10% and 12%, 7 assets (12% of total balance) with NOI debt yield between 12% and 14%, 5 assets (15% of total balance) with NOI debt yield between 14% and 16%, 3 assets (7% of total balance) with NOI debt yield between 16% and 18%, 4 assets (12% of total balance) with NOI debt yield between 18% and 20%, 1 assets (4% of total balance) with NOI debt yield between 26% and 28%

NCF DSCR ranged from 0.0x to 6.0x. There were 1 assets (0.5% of total balance) with NCF DSCR between 0.5x and 1.0x, 13 assets (15.2% of total balance) with NCF DSCR between 1.0x and 1.5x, 10 assets (20.3% of total balance) with NCF DSCR between 1.5x and 2.0x, 8 assets (16.2% of total balance) with NCF DSCR between 2.0x and 2.5x, 7 assets (18.0% of total balance) with NCF DSCR between 2.5x and 3.0x, 4 assets (7.5% of total balance) with NCF DSCR between 3.0x and 3.5x, 3 assets (13.3% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (9.0% of total balance) with NCF DSCR between 6.0x and 6.5x. 



DSCRs ranged from 0.5x to 6.5x. There are 1 assets (0.5% of total balance) with DSCR between 0.5x and 1.0x, 9 assets (10.2% of total balance) with DSCR between 1.0x and 1.5x, 11 assets (22.7% of total balance) with DSCR between 1.5x and 2.0x, 7 assets (7.5% of total balance) with DSCR between 2.0x and 2.5x, 8 assets (16.0% of total balance) with DSCR between 2.5x and 3.0x, 4 assets (13.7% of total balance) with DSCR between 3.0x and 3.5x, 4 assets (9.2% of total balance) with DSCR between 3.5x and 4.0x, 2 assets (11.0% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (9.0% of total balance) with DSCR between 6.0x and 6.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
