Transaction Summary

The transaction closed on Nov 14 2016 and matures in Nov 2026. The pool's current aggregate principal balance is \$907.8 million compared to \$946.3 million at close.

The largest loan of the pool (8.8%) is secured by Huntington Center located in metropolitan area. Occupancy at the subject was 86%. The major tenants included Huntington National Bank (21.97%) and Porter Wright Morris & Arthur (12.69%). The second largest loan of the pool (7.6%) is secured by One Met Life Way located in Newark, NJ-PA metropolitan area. Occupancy at the subject was 100%. The largest tenant was Metropolitan Life Insurance (100.00%). The third largest loan of the pool (5.6%) is secured by Hyatt Regency Sarasota located in metropolitan area. Occupancy at the subject was 56%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.32% and 51 months as of 12/15/2020, respectively. There are a total of 59 loans and 100 properties in the portfolio. The appraisal LTV was approximately 69.7% compared to the Original loan to value (LTV), which was approximately 63.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.80x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.





Occupancy Distribution (%)









Most recent net operating income debt yield ranged from 4% to 29% with a weighted average NOI debt yield of 10.5%. NOI debt yield ranged from 4% to 29%. There were 1 assets (5% of total balance) with NOI debt yield between 4% and 6%, 6 assets (16% of total balance) with NOI debt yield between 6% and 8%, 13 assets (35% of total balance) with NOI debt yield between 8% and 10%, 21 assets (22% of total balance) with NOI debt yield between 10% and 12%, 2 assets (2% of total balance) with NOI debt yield between 12% and 14%, 8 assets (9% of total balance) with NOI debt yield between 14% and 16%, 5 assets (9% of total balance) with NOI debt yield between 16% and 18%, 2 assets (1% of total balance) with NOI debt yield between 18% and 20%, 1 assets (1% of total balance) with NOI debt yield between 28% and 30%

There were 1 assets (0.5% of total balance) with NCF DSCR between 0.0x and 0.5x, 5 assets (12.1% of total balance) with NCF DSCR between 0.5x and 1.0x, 14 assets (23.3% of total balance) with NCF DSCR between 1.0x and 1.5x, 22 assets (40.0% of total balance) with NCF DSCR between 1.5x and 2.0x, 10 assets (10.1% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (5.1% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (3.3% of total balance) with NCF DSCR between 3.0x and 3.5x, 2 assets (2.3% of total balance) with NCF DSCR between 3.5x and 4.0x and 2 assets (3.4% of total balance) with NCF DSCR between 4.0x and 4.5x. 



There are 4 assets (11.5% of total balance) with DSCR between 0.5x and 1.0x, 10 assets (20.0% of total balance) with DSCR between 1.0x and 1.5x, 21 assets (28.0% of total balance) with DSCR between 1.5x and 2.0x, 12 assets (19.5% of total balance) with DSCR between 2.0x and 2.5x, 7 assets (12.0% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (5.6% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (2.8% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (0.6% of total balance) with DSCR between 4.5x and 5.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
