## Transaction Summary

The transaction closed on Nov 14 2016 and matures in Nov 2026. The pool's current aggregate principal balance is \$848.3 million compared to \$900.5 million at close.

The largest loan of the pool (9.4%) is secured by Huntington Center located in metropolitan area. Occupancy at the subject was 83%. The major tenants included Huntington National Bank (21.97%) and Porter Wright Morris & Arthur (12.69%). The second largest loan of the pool (8.1%) is secured by One Met Life Way located in Newark, NJ-PA metropolitan area. Occupancy at the subject was 100%. The largest tenant was Met Life (100.00%). The third largest loan of the pool (5.8%) is secured by Hyatt Regency Sarasota located in metropolitan area. Occupancy at the subject was 58%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.29% and 66 months as of 03/15/2022, respectively. There are a total of 54 loans and 93 properties in the portfolio. The appraisal LTV was approximately 64.5% compared to the Original loan to value (LTV), which was approximately 62.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.77x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 85%.

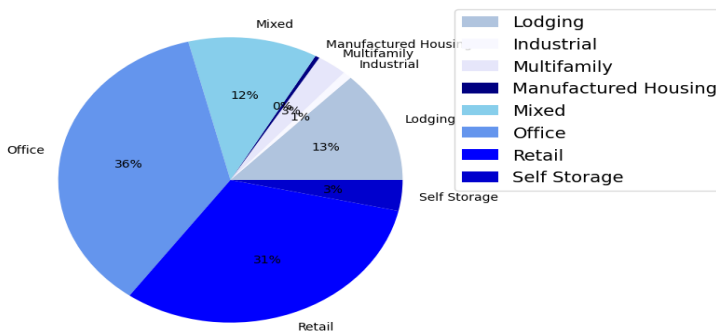

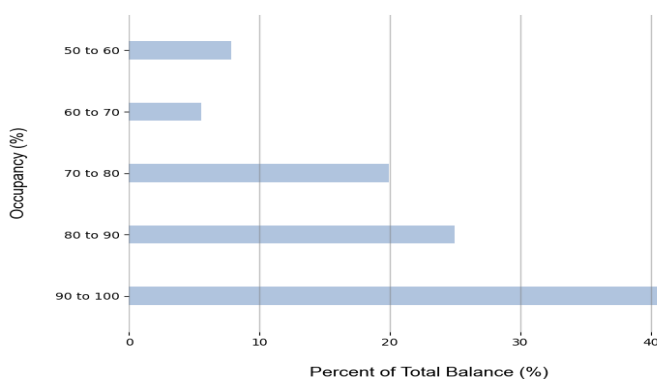

### Occupancy Distribution (%)

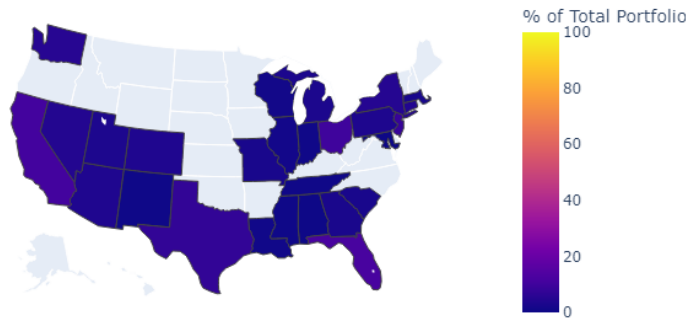

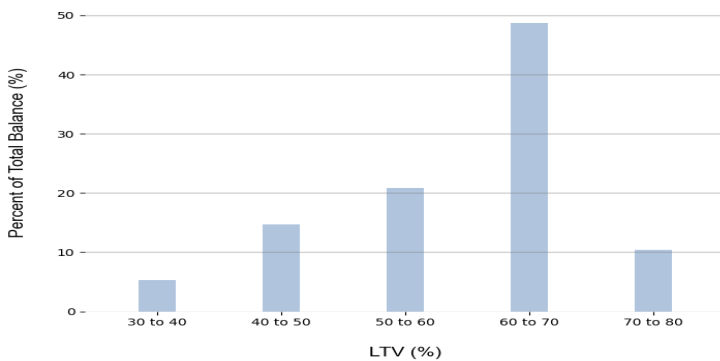
Local Distribution

LTV Distribution (%)



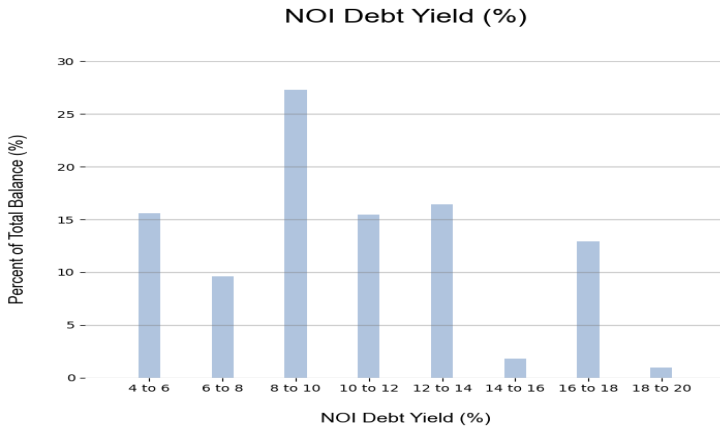

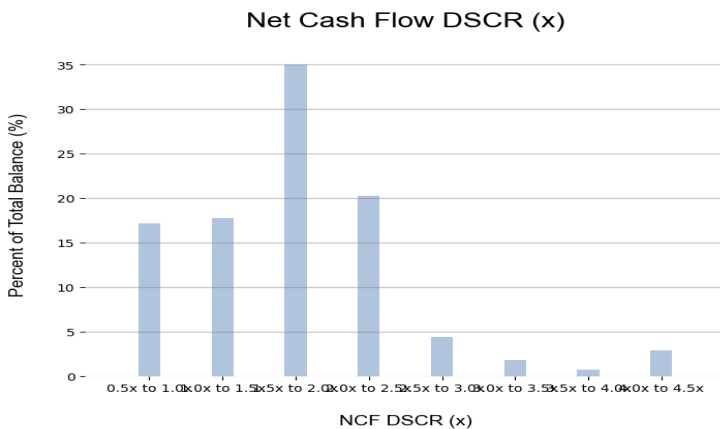

Most recent net operating income debt yield ranged from 4% to 19% with a weighted average NOI debt yield of 10.5%. NOI debt yield ranged from 4% to 19%. There were 4 assets (16% of total balance) with NOI debt yield between 4% and 6%, 3 assets (10% of total balance) with NOI debt yield between 6% and 8%, 9 assets (27% of total balance) with NOI debt yield between 8% and 10%, 15 assets (15% of total balance) with NOI debt yield between 10% and 12%, 12 assets (16% of total balance) with NOI debt yield between 12% and 14%, 4 assets (2% of total balance) with NOI debt yield between 14% and 16%, 6 assets (13% of total balance) with NOI debt yield between 16% and 18% and 1 assets (1% of total balance) with NOI debt yield between 18% and 20%.

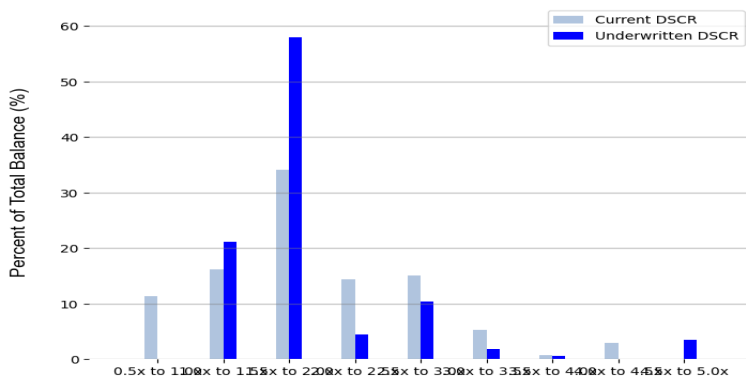


NCF DSCR ranged from 0.5x to 4.5x. There were 5 assets (17.2% of total balance) with NCF DSCR between 0.5x and 1.0x, 15 assets (17.8% of total balance) with NCF DSCR between 1.0x and 1.5x, 18 assets (35.0% of total balance) with NCF DSCR between 1.5x and 2.0x, 11 assets (20.3% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (4.4% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (1.8% of total balance) with NCF DSCR between 3.0x and 3.5x, 1 assets (0.7% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (2.9% of total balance) with NCF DSCR between 4.0x and 4.5x. 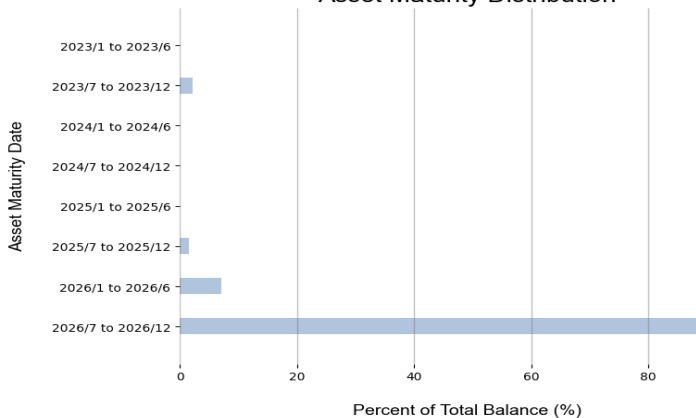
**DSCR Distribution (x)**



DSCRs ranged from 0.5x to 4.5x. There are 4 assets (11.3% of total balance) with DSCR between 0.5x and 1.0x, 8 assets (16.2% of total balance) with DSCR between 1.0x and 1.5x, 21 assets (34.1% of total balance) with DSCR between 1.5x and 2.0x, 13 assets (14.4% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (15.0% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (5.3% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.7% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (2.9% of total balance) with DSCR between 4.0x and 4.5x. The most recent weighted average DSCR is 1.9x.

There are 2 assets (18.4% of total balance) that have maturity dates between 2023/7 and 2023/12, 1 assets (13.3% of total balance) that have maturity dates between 2025/7 and 2025/12, 5 assets (60.7% of total balance) that have maturity dates between 2026/1 and 2026/6 and 46 assets (755.9% of total balance) that have maturity dates between 2026/7 and 2026/12.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
