### **Transaction Summary**

The transaction closed on Dec 21 2016 and matures in Jan 2027. The pool's current aggregate principal balance is \$849.2 million compared to \$887.4 million at close.

The largest loan of the pool (7.4%) is secured by Hilton Hawaiian Village - Trust located in metropolitan area. Occupancy at the subject was 55%. The second largest loan of the pool (6.5%) is secured by 191 Peachtree located in metropolitan area. Occupancy at the subject was 87%. The major tenants included Deloitte & Touche (21.27%) and HNTB Corporation (7.17%). The third largest loan of the pool (6.1%) is secured by Wolfchase Galleria located in metropolitan area. Occupancy at the subject was 79%. The major tenants included Malco Theatres (7.92%) and H&M (5.65%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.30% and 65 months as of 04/15/2022, respectively. There are a total of 52 loans and 72 properties in the portfolio. The appraisal LTV was approximately 56.0% compared to the Original loan to value (LTV), which was approximately 58.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.16x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.





#### Occupancy Distribution (%)




#### Local Distribution





Most recent net operating income debt yield ranged from 4% to 21% with a weighted average NOI debt yield of 11.4%. NOI debt yield ranged from 4% to 21%. There were 1 assets (0% of total balance) with NOI debt yield between 4% and 6%, 4 assets (10% of total balance) with NOI debt yield between 6% and 8%, 12 assets (17% of total balance) with NOI debt yield between 8% and 10%, 15 assets (27% of total balance) with NOI debt yield between 10% and 12%, 10 assets (27% of total balance) with NOI debt yield between 12% and 14%, 7 assets (16% of total balance) with NOI debt yield between 14% and 16%, 1 assets (0% of total balance) with NOI debt yield between 16% and 18%, 1 assets (0% of total balance) with NOI debt yield between 18% and 20% and 1 assets (0% of total balance) with NOI debt yield between 20% and 22%.

NCF DSCR ranged from 0.5x to 5.0x. There were 3 assets (1.5% of total balance) with NCF DSCR between 0.5x and 1.0x, 19 assets (33.7% of total balance) with NCF DSCR between 1.0x and 1.5x, 12 assets (19.0% of total balance) with NCF DSCR between 1.5x and 2.0x, 6 assets (11.8% of total balance) with NCF DSCR between 2.0x and 2.5x, 4 assets (12.2% of total balance) with NCF DSCR between 2.5x and 3.0x, 4 assets (8.5% of total balance) with NCF DSCR between 3.0x and 3.5x, 2 assets (6.8% of total balance) with NCF DSCR between 3.5x and 4.0x, 1 assets (6.1% of total balance) with NCF DSCR between 4.0x and 4.5x and 1 assets (0.4% of total balance) with NCF DSCR between 4.5x and 5.0x. 



DSCRs ranged from 0.5x to 5.0x. There are 2 assets (0.8% of total balance) with DSCR between 0.5x and 1.0x, 13 assets (22.7% of total balance) with DSCR between 1.0x and 1.5x, 16 assets (26.5% of total balance) with DSCR between 1.5x and 2.0x, 8 assets (8.6% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (8.1% of total balance) with DSCR between 2.5x and 3.0x, 7 assets (20.0% of total balance) with DSCR between 3.0x and 3.5x, 2 assets (6.8% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (6.1% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (0.4% of total balance) with DSCR between 4.5x and 5.0x. ### EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
