Transaction Summary

The transaction closed on May 11 2017 and matures in May 2027. The pool's current aggregate principal balance is \$601.7 million compared to \$631.8 million at close.

The largest loan of the pool (8.6%) is secured by SSTII Mindful Portfolio located in West Palm Beach-Boca Raton-Delray Beach, FL-83.48% Fort Lauderdale-Pompano Beach-Deerfield Beach, FL-16.52% metropolitan area. Occupancy at the subject was 96%. The second largest loan of the pool (8.3%) is secured by Pentagon Center located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 100%. The major tenants included United States Government (61.22%) and United States Government (38.78%). The third largest loan of the pool (6.8%) is secured by Pearlridge Uptown II located in metropolitan area. Occupancy at the subject was 99%. The major tenants included Ross Dress For Less (20.14%) and TJ Maxx (16.29%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.73% and 60 months as of 03/15/2022, respectively. There are a total of 41 loans and 67 properties in the portfolio. The appraisal LTV was approximately 58.8% compared to the Original loan to value (LTV), which was approximately 59.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.83x. As of 03/15/2022, 1.77% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.



Type Concentration











DSCRs ranged from -0.5x to 5.0x.There are 1 assets (1.7% of total balance) with DSCR between -0.5x and 0.0x, 2 assets (3.7% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (1.0% of total balance) with DSCR between 0.5x and 1.0x, 7 assets (18.3% of total balance) with DSCR between 1.0x and 1.5x, 17 assets (34.1% of total balance) with DSCR between 1.5x and 2.0x, 5 assets (17.1% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (22.5% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (0.6% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (1.0% of total balance) with DSCR between 4.5x and 5.0x. There are 1 assets (10.7% of total balance) that have maturity dates between 2022/1 and 2022/6, 1 assets (8.4% of total balance) that have maturity dates between 2024/1 and 2024/6, 1 assets (41.0% of total balance) that have maturity dates between 2025/1 and 2025/6, 4 assets (48.1% of total balance) that have maturity dates between 2026/7 and 2026/12 and 34 assets (493.5% of total balance) that have maturity dates between 2027/1 and 2027/6.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
