Transaction Summary

The transaction closed on Oct 19 2017 and matures in Sep 2042. The pool's current aggregate principal balance is \$1032.0 million compared to \$1049.0 million at close.

The largest loan of the pool (9.7%) is secured by 222 Second Street located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 100%. The major tenants included Linked Incorporated (32.86%) and Linked Incorporated (29.93%). The second largest loan of the pool (7.1%) is secured by American Cancer Society Center located in metropolitan area. Occupancy at the subject was 89%. The major tenants included American Cancer Society (27.76%) and US SOUTH COMMUNICATION INC (22.69%). The third largest loan of the pool (6.8%) is secured by 237 Park Avenue - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 99%. The major tenants included The New York and Presbyterian Hospital (38.30%) and JP Morgan Chase (20.30%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.20% and 39 months as of 12/15/2020, respectively. There are a total of 50 loans and 179 properties in the portfolio. The appraisal LTV was approximately 58.5% compared to the Original loan to value (LTV), which was approximately 59.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.17x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.

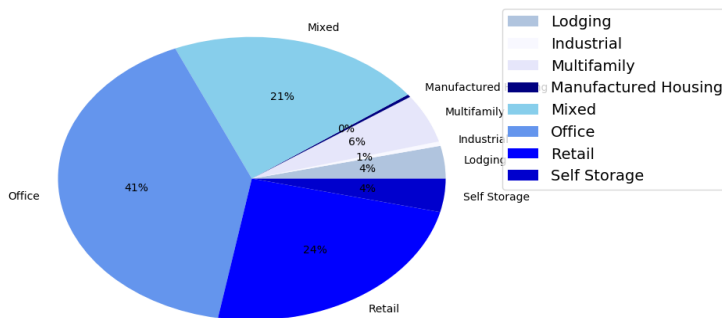

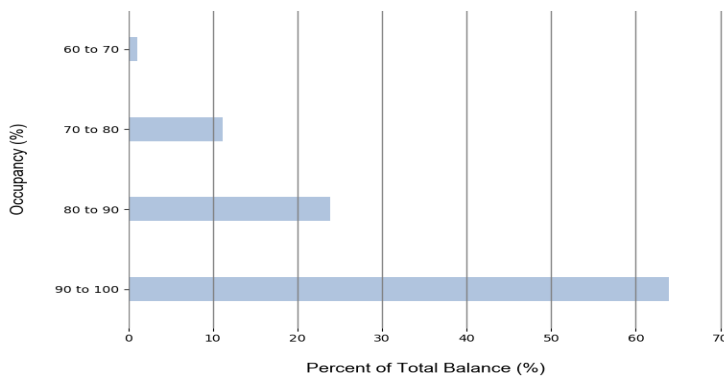

Occupancy Distribution (%)

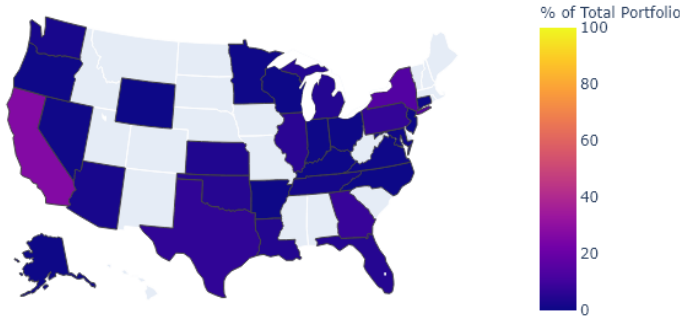

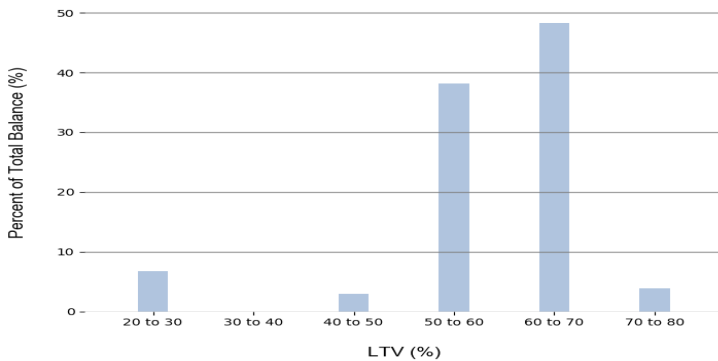
Local Distribution

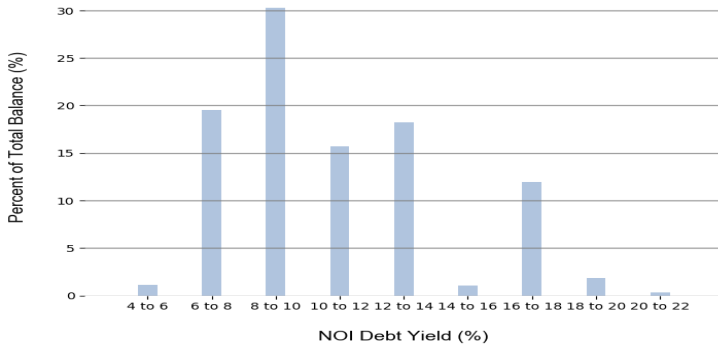

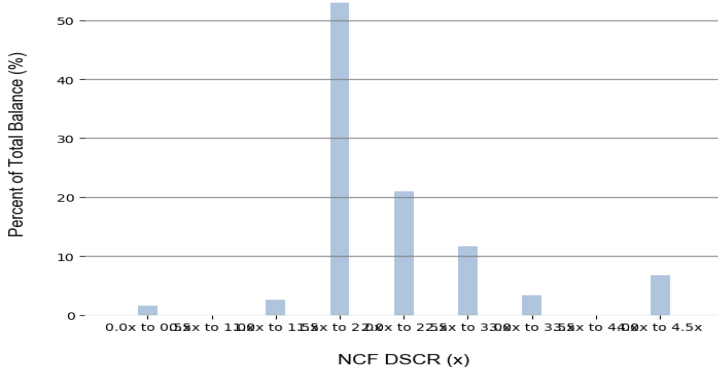
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 4% to 21% with a weighted average NOI debt yield of 11.0%. NOI debt yield ranged from 4% to 21%. Net Cash Flow DSCR (x)

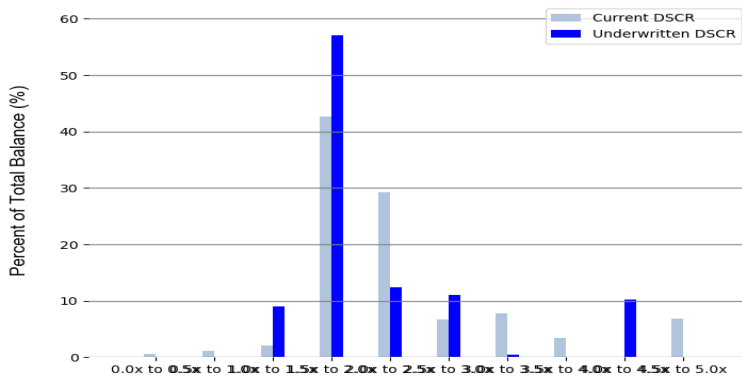

There were 2 assets (1.6% of total balance) with NCF DSCR between 0.0x and 0.5x, 6 assets (2.6% of total balance) with NCF DSCR between 1.0x and 1.5x, 20 assets (52.9% of total balance) with NCF DSCR between 1.5x and 2.0x, 13 assets (21.0% of total balance) with NCF DSCR between 2.0x and 2.5x, 7 assets (11.6% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (3.4% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (6.8% of total balance) with NCF DSCR between 4.0x and 4.5x. 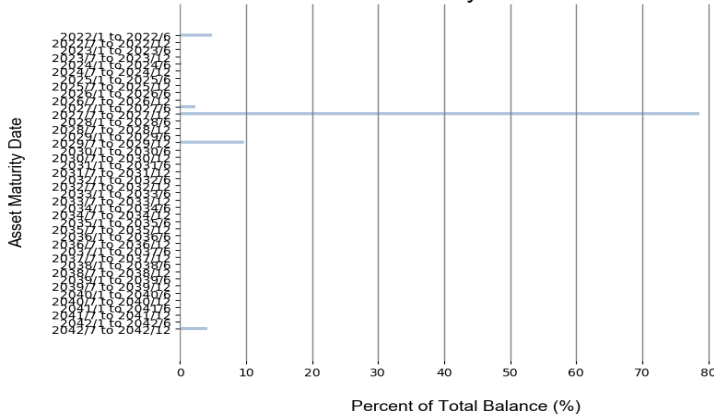
DSCR Distribution (x)



DSCRs ranged from 0.0x to 5.0x. There are 1 assets (0.5% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (1.1% of total balance) with DSCR between 0.5x and 1.0x, 5 assets (2.0% of total balance) with DSCR between 1.0x and 1.5x, 17 assets (42.6% of total balance) with DSCR between 1.5x and 2.0x, 15 assets (29.2% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (6.7% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (7.7% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (3.4% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (6.8% of total balance) with DSCR between 4.5x and 5.0x. There are 1 assets (4.8% of total balance) that have maturity dates between 2022/1 and 2022/6, 1 assets (0.3% of total balance) that have maturity dates between 2024/1 and 2024/6, 1 assets (2.4% of total balance) that have maturity dates between 2027/1 and 2027/6, 45 assets (78.6% of total balance) that have maturity dates between 2027/7 and 2027/12, 1 assets (9.7% of total balance) that have maturity dates between 2029/7 and 2029/12 and 1 assets (4.2% of total balance) that have maturity dates between 2042/7 and 2042/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
