Transaction Summary

The transaction closed on Oct 19 2017 and matures in Sep 2042. The pool's current aggregate principal balance is \$1014.9 million compared to \$1040.0 million at close.

The largest loan of the pool (9.9%) is secured by 222 Second Street located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 100%. The major tenants included Linked Incorporated (34.63%) and Linked Incorporated (32.86%). The second largest loan of the pool (7.2%) is secured by American Cancer Society Center located in metropolitan area. Occupancy at the subject was 64%. The major tenants included US SOUTH COMMUNICATION INC (22.69%) and GEORGIA LOTTERY CORPORATION (12.87%). The third largest loan of the pool (6.9%) is secured by 237 Park Avenue - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 97%. The major tenants included The New York and Presbyterian Hospital (38.30%) and JP Morgan Chase (20.30%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.19% and 54 months as of 03/15/2022, respectively. There are a total of 47 loans and 176 properties in the portfolio. The appraisal LTV was approximately 59.1% compared to the Original loan to value (LTV), which was approximately 59.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.04x. As of 03/15/2022, 4.88% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.

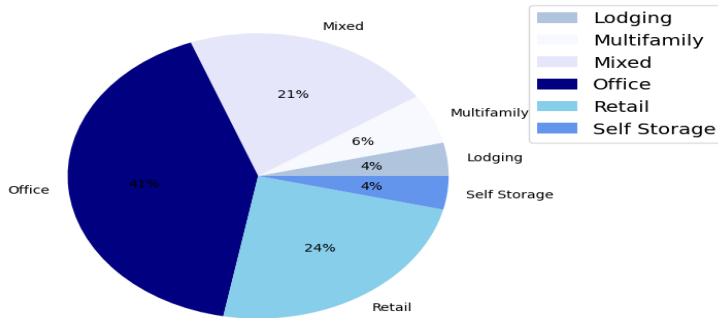

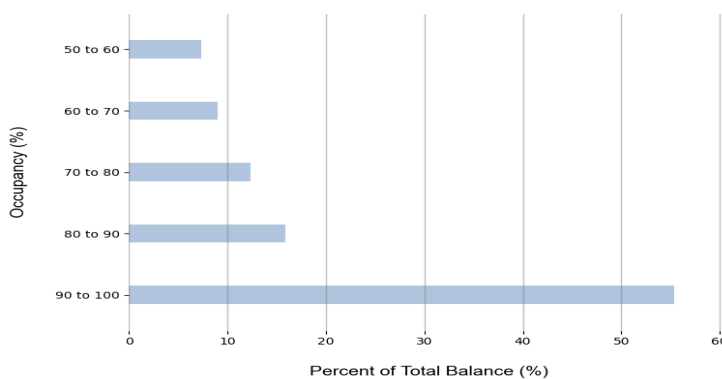

Occupancy Distribution (%)

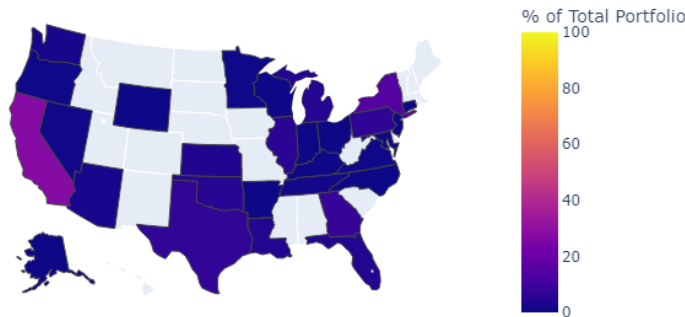

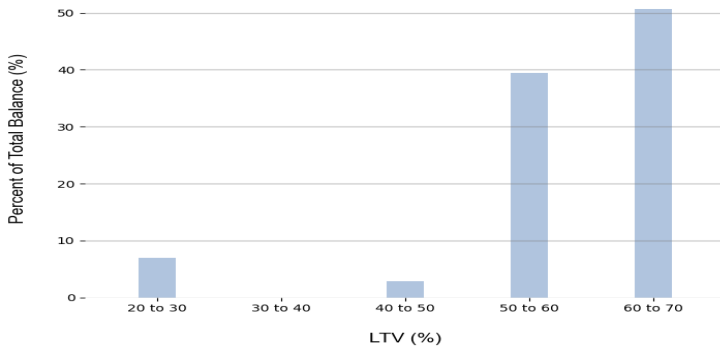
Local Distribution

LTV Distribution (%)



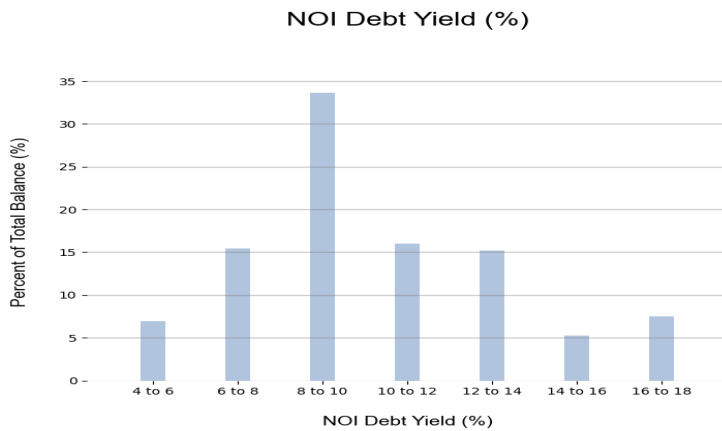

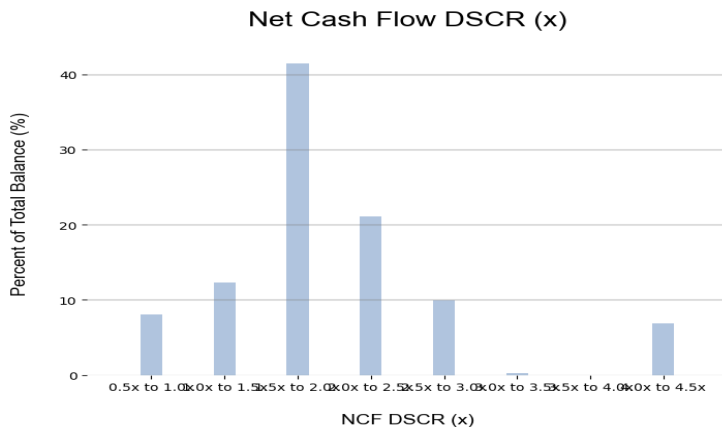

Most recent net operating income debt yield ranged from 4% to 17% with a weighted average NOI debt yield of 10.2%. NOI debt yield ranged from 4% to 17%. There were 2 assets (7% of total balance) with NOI debt yield between 4% and 6%, 5 assets (15% of total balance) with NOI debt yield between 6% and 8%, 13 assets (34% of total balance) with NOI debt yield between 8% and 10%, 11 assets (16% of total balance) with NOI debt yield between 10% and 12%, 9 assets (15% of total balance) with NOI debt yield between 12% and 14%, 4 assets (5% of total balance) with NOI debt yield between 14% and 16% and 3 assets (8% of total balance) with NOI debt yield between 16% and 18%.

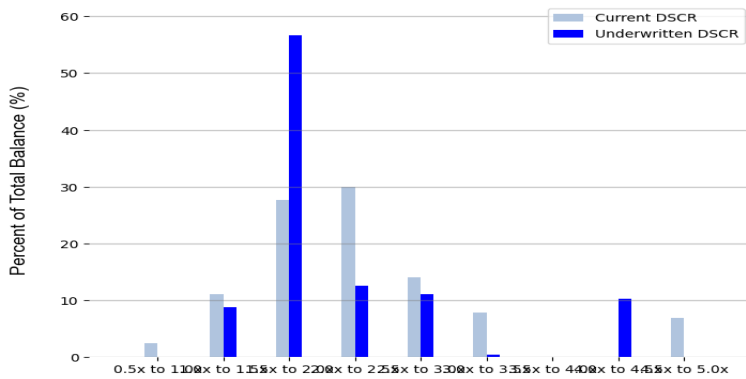

There were 3 assets (8.0% of total balance) with NCF DSCR between 0.5x and 1.0x, 10 assets (12.3% of total balance) with NCF DSCR between 1.0x and 1.5x, 17 assets (41.5% of total balance) with NCF DSCR between 1.5x and 2.0x, 10 assets (21.1% of total balance) with NCF DSCR between 2.0x and 2.5x, 5 assets (9.9% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (0.2% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (6.9% of total balance) with NCF DSCR between 4.0x and 4.5x. 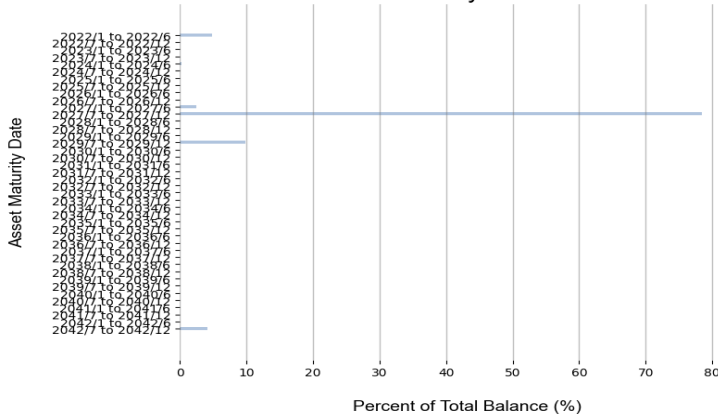
DSCR Distribution (x)



DSCRs ranged from 0.5x to 5.0x. There are 1 assets (2.5% of total balance) with DSCR between 0.5x and 1.0x, 8 assets (11.1% of total balance) with DSCR between 1.0x and 1.5x, 14 assets (27.7% of total balance) with DSCR between 1.5x and 2.0x, 13 assets (30.0% of total balance) with DSCR between 2.0x and 2.5x, 7 assets (14.0% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (7.9% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (6.9% of total balance) with DSCR between 4.5x and 5.0x. The most recent weighted average DSCR is 2.2x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
