Transaction Summary

The transaction closed on Jul 08 2015 and matures in May 2045. The pool's current aggregate principal balance is \$849.8 million compared to \$886.2 million at close.

The largest loan of the pool (9.4%) is secured by TKG 3 Retail Portfolio located in metropolitan area. Occupancy at the subject was 98%. The major tenants included Walmart (14.42%) and Lowe's Home Improvement (9.18%). The second largest loan of the pool (7.9%) is secured by 300 South Riverside Plaza Fee located in metropolitan area. Occupancy at the subject was 79%. The major tenants included CARS.COM LLC (29.98%) and Zurich American Insurance Company (20.43%). The third largest loan of the pool (7.1%) is secured by 32 Old Slip Fee located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The largest tenant was RXR OLD SLIP OWNER LLC (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.06% and 67 months as of 12/15/2020, respectively. There are a total of 54 loans and 59 properties in the portfolio. The appraisal LTV was approximately 61.3% compared to the Original loan to value (LTV), which was approximately 62.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.22x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 93%.





Occupancy Distribution (%)




Local Distribution









DSCRs ranged from 0.0x to 10.5x. There are 1 assets (0.3% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (0.3% of total balance) with DSCR between 0.5x and 1.0x, 13 assets (28.8% of total balance) with DSCR between 1.0x and 1.5x, 17 assets (33.5% of total balance) with DSCR between 1.5x and 2.0x, 13 assets (24.5% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (2.1% of total balance) with DSCR between 2.5x and 3.0x. 2 assets (2.5% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.4% of total balance) with DSCR between 4.0x and 4.5x, 2 assets (1.7% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (5.9% of total balance) with DSCR between 10.0x and 10.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
