Transaction Summary

The transaction closed on Nov 22 2016 and matures in Nov 2026. The pool's current aggregate principal balance is \$639.6 million compared to \$677.7 million at close.

The largest loan of the pool (11.3%) is secured by 101 Hudson Street located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 74%. The major tenants included Merrill Lynch (28.94%) and FIRST DATA CORPORATION (5.99%). The second largest loan of the pool (10.6%) is secured by Harlem USA located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 74%. The major tenants included AMC Cinema (27.69%) and Old Navy (14.15%). The third largest loan of the pool (6.4%) is secured by Marriott Albany located in metropolitan area. Occupancy at the subject was 24%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.91% and 66 months as of 04/15/2022, respectively. There are a total of 38 loans and 39 properties in the portfolio. The appraisal LTV was approximately 58.6% compared to the Original loan to value (LTV), which was approximately 60.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.74x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 77%.

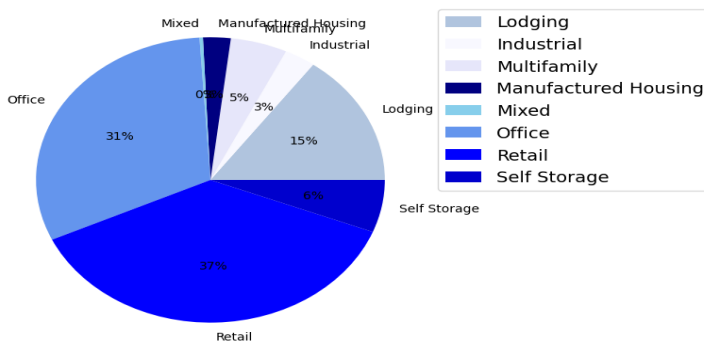

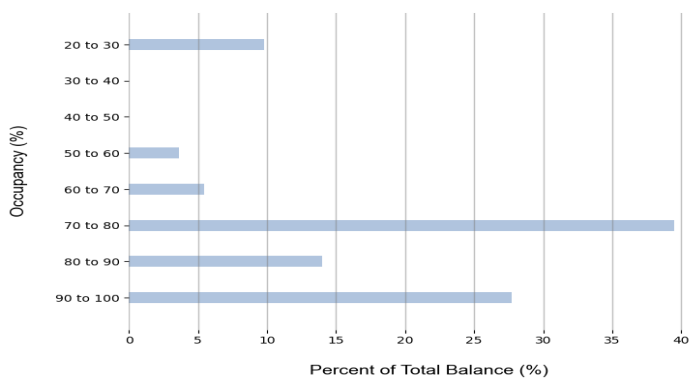

Occupancy Distribution (%)

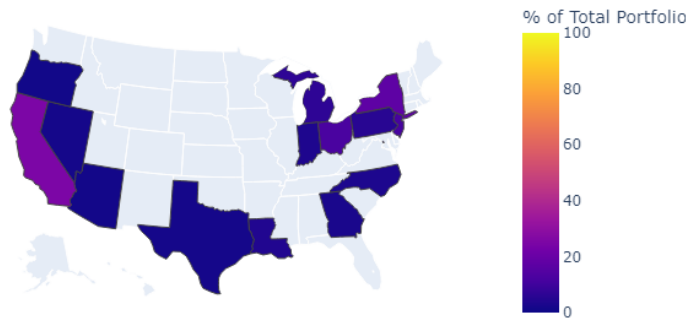

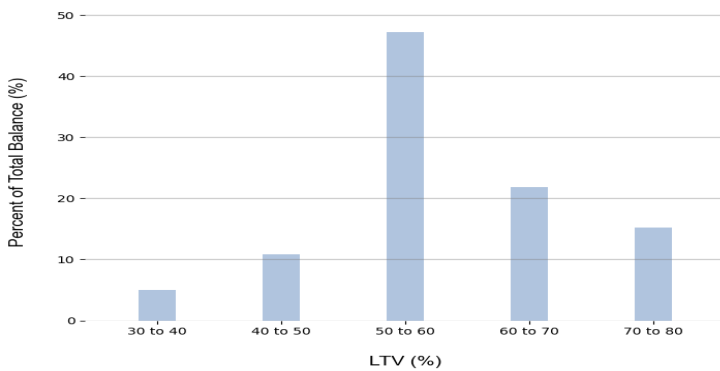
Local Distribution

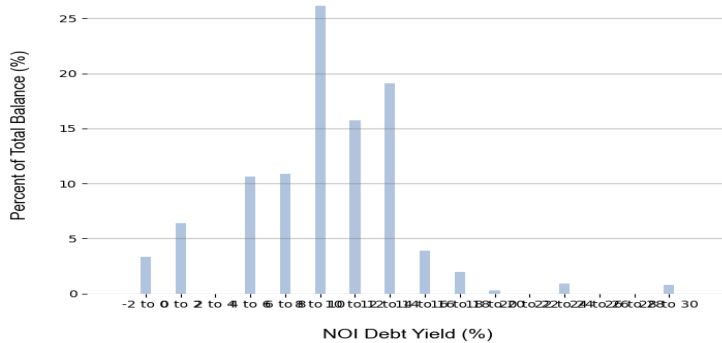

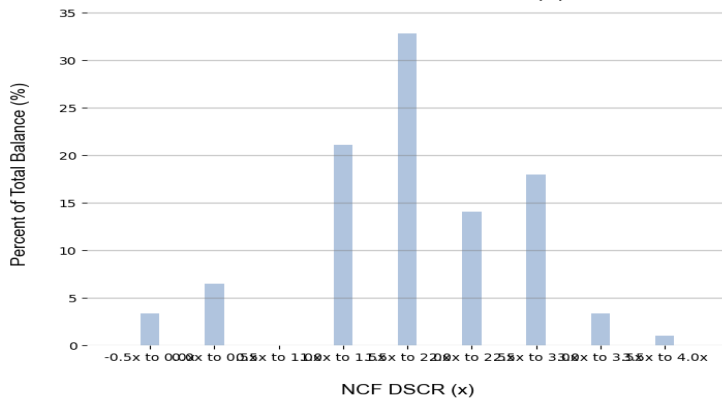

There were 1 assets (3.4% of total balance) with NCF DSCR between -0.5x and 0.0x, 1 assets (6.4% of total balance) with NCF DSCR between 0.0x and 0.5x, 8 assets (21.0% of total balance) with NCF DSCR between 1.0x and 1.5x, 11 assets (32.8% of total balance) with NCF DSCR between 1.5x and 2.0x, 8 assets (14.1% of total balance) with NCF DSCR between 2.0x and 2.5x, 5 assets (18.0% of total balance) with NCF DSCR between 2.5x and 3.0x, 3 assets (3.4% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (1.0% of total balance) with NCF DSCR between 3.5x and 4.0x. 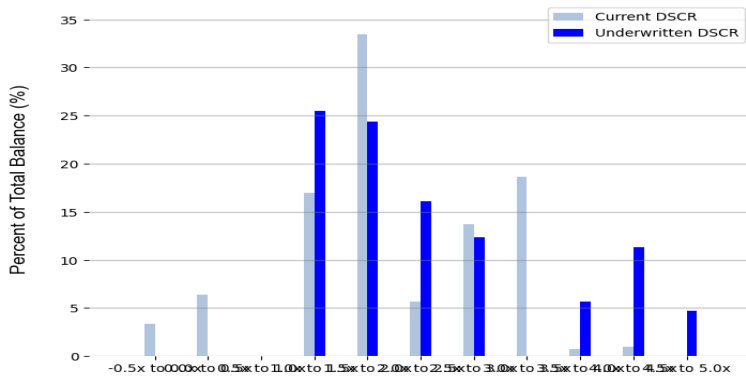
Net Cash Flow DSCR (x)

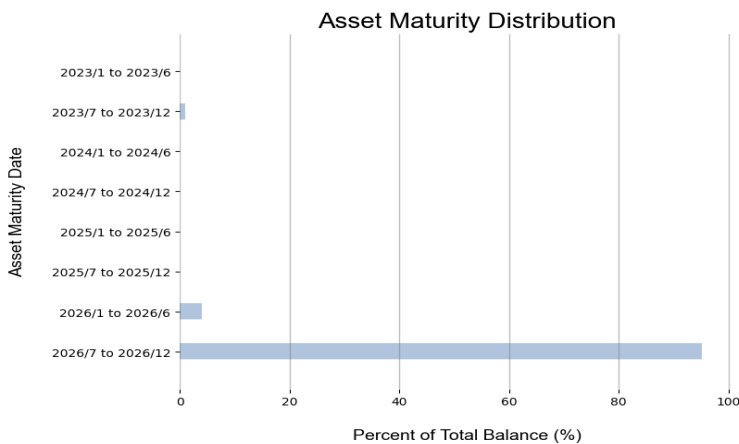

DSCRs ranged from -0.5x to 4.5x. There are 1 assets (3.4% of total balance) with DSCR between -0.5x and 0.0x, 1 assets (6.4% of total balance) with DSCR between 0.0x and 0.5x, 6 assets (17.0% of total balance) with DSCR between 1.0x and 1.5x, 10 assets (33.4% of total balance) with DSCR between 1.5x and 2.0x, 7 assets (5.7% of total balance) with DSCR between 2.0x and 2.5x, 7 assets (13.7% of total balance) with DSCR between 2.5x and 3.0x, 4 assets (18.6% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.8% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (1.0% of total balance) with DSCR between 4.0x and 4.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
