## **Transaction Summary**

The transaction closed on Dec 07 2016 and matures in Nov 2041. The pool's current aggregate principal balance is \$792.7 million compared to \$825.0 million at close.

The largest loan of the pool (10.1%) is secured by 681 Fifth Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 59%. The major tenants included TOMMY HILFIGER RETAIL (27.26%) and Metropole Realty Advisors (9.25%). The second largest loan of the pool (10.1%) is secured by 191 Peachtree located in metropolitan area. Occupancy at the subject was 92%. The major tenants included Deloitte & Touche (21.49%) and HALL BOOTH SMITH (6.33%). The third largest loan of the pool (8.2%) is secured by Wolfchase Galleria located in metropolitan area. Occupancy at the subject was 81%. The major tenants included Macy's (64.58%) and Dillard's (52.12%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.16% and 49 months as of 12/15/2020, respectively. There are a total of 42 loans and 78 properties in the portfolio. The appraisal LTV was approximately 60.0% compared to the Original loan to value (LTV), which was approximately 61.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.86x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 85%.





#### Occupancy Distribution (%)




#### Local Distribution





Most recent net operating income debt yield ranged from 6% to 27% with a weighted average NOI debt yield of 10.0%. NOI debt yield ranged from 6% to 27%. There were 5 assets (19% of total balance) with NOI debt yield between 6% and 8%, 9 assets (37% of total balance) with NOI debt yield between 8% and 10%, 10 assets (16% of total balance) with NOI debt yield between 10% and 12%, 12 assets (23% of total balance) with NOI debt yield between 12% and 14%, 2 assets (2% of total balance) with NOI debt yield between 14% and 16%, 2 assets (3% of total balance) with NOI debt yield between 16% and 18%, 1 assets (0% of total balance) with NOI debt yield between 18% and 20%, 1 assets (0% of total balance) with NOI debt yield between 26% and 28%

There were 6 assets (16.7% of total balance) with NCF DSCR between 0.0x and 0.5x, 1 assets (3.9% of total balance) with NCF DSCR between 0.5x and 1.0x, 9 assets (38.0% of total balance) with NCF DSCR between 1.0x and 1.5x, 16 assets (13.4% of total balance) with NCF DSCR between 1.5x and 2.0x, 5 assets (4.7% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (17.3% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (5.7% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (0.2% of total balance) with NCF DSCR between 3.5x and 4.0x. 



DSCRs ranged from 0.0x to 4.5x.There are 6 assets (16.7% of total balance) with DSCR between 0.0x and 0.5x, 8 assets (39.1% of total balance) with DSCR between 1.0x and 1.5x, 14 assets (10.7% of total balance) with DSCR between 1.5x and 2.0x, 6 assets (7.1% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (7.7% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (18.4% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (0.2% of total balance) with DSCR between 4.0x and 4.5x. The most recent weighted average DSCR is 2.0x.

# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
