# **Transaction Summary**

The transaction closed on Dec 22 2017 and matures in Dec 2029. The pool's current aggregate principal balance is \$933.7 million compared to \$942.8 million at close.

The largest loan of the pool (9.9%) is secured by ExtraSpace Self Storage Portfolio located in Camden, NJ-15.34% Montgomery County-Bucks County-Chester County, PA-10.43% Cambridge-Newton-Framingham, MA-3.93% New York-Jersey City-White Plains, NY-NJ-3.42% metropolitan area. Occupancy at the subject was 93%. The second largest loan of the pool (9.1%) is secured by The Woods located in metropolitan area. Occupancy at the subject was 93%. The third largest loan of the pool (8.6%) is secured by Baybrook Lifestyle and Power Center located in metropolitan area. Occupancy at the subject was 98%. The major tenants included Lifetime Fitness (18.84%) and Dick's Clothing and Sporting Goods (16.49%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.25% and 36 months as of 12/15/2020, respectively. There are a total of 42 loans and 82 properties in the portfolio. The appraisal LTV was approximately 57.3% compared to the Original loan to value (LTV), which was approximately 57.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.68x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 93%.





## Occupancy Distribution (%)




### Local Distribution





Most recent net operating income debt yield ranged from 4% to 27% with a weighted average NOI debt yield of 11.5%. NOI debt yield ranged from 4% to 27%. There were 1 assets (2% of total balance) with NOI debt yield between 4% and 6%, 2 assets (3% of total balance) with NOI debt yield between 6% and 8%, 18 assets (37% of total balance) with NOI debt yield between 8% and 10%, 7 assets (28% of total balance) with NOI debt yield between 10% and 12%, 5 assets (7% of total balance) with NOI debt yield between 12% and 14%, 5 assets (19% of total balance) with NOI debt yield between 14% and 16%, 1 assets (1% of total balance) with NOI debt yield between 18% and 20%, 2 assets (3% of total balance) with NOI debt yield between 20% and 22%, 1 assets (1% of total balance) with NOI debt yield between 26% and 28%



### **Current DSCR**



DSCRs ranged from 0.5x to 5.5x. There are 1 assets (2.4% of total balance) with DSCR between 0.5x and 1.0x, 5 assets (5.3% of total balance) with DSCR between 1.0x and 1.5x, 11 assets (15.2% of total balance) with DSCR between 1.5x and 2.0x, 9 assets (21.1% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (22.9% of total balance) with DSCR between 2.5x and 3.0x, 5 assets (13.7% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.8% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (0.8% of total balance) with DSCR between 4.0x and 4.5x, 2 assets (5.4% of total balance) with DSCR between 4.5x and 5.0x and 2 assets (12.5% of total balance) with DSCR between 5.0x and 5.5x. # EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:

- 1). Are not intended to address the value, price, price stability, liquidity, suitability, or merit of an investment.
- 2). Do not address whether a particular rated security is suitable for a particular investor or suitable for an investor's risk tolerance.
