Transaction Summary

The transaction closed on Jul 12 2018 and matures in May 2038. The pool's current aggregate principal balance is \$1014.7 million compared to \$1024.7 million at close.

The largest loan of the pool (7.9%) is secured by Griffin Portfolio II located in Elgin, IL-17.44% metropolitan area. Occupancy at the subject was 100%. The major tenants included 3M COMPANY (35.88%) and Amazon.com (31.41%). The second largest loan of the pool (5.1%) is secured by 6330 West Loop South located in metropolitan area. Occupancy at the subject was 95%. The major tenants included Texas Children's Health Plan Inc (49.75%) and Jones & Carter (17.18%). The third largest loan of the pool (4.9%) is secured by Rittenhouse Hill located in Philadelphia, PA metropolitan area. Occupancy at the subject was 90%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.87% and 30 months as of 12/15/2020, respectively. There are a total of 66 loans and 120 properties in the portfolio. The appraisal LTV was approximately 61.3% compared to the Original loan to value (LTV), which was approximately 61.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.86x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.





Occupancy Distribution (%)











Most recent net operating income debt yield ranged from 4% to 21% with a weighted average NOI debt yield of 10.4%. NOI debt yield ranged from 4% to 21%. There were 2 assets (2% of total balance) with NOI debt yield between 4% and 6%, 7 assets (10% of total balance) with NOI debt yield between 6% and 8%, 16 assets (31% of total balance) with NOI debt yield between 8% and 10%, 22 assets (37% of total balance) with NOI debt yield between 10% and 12%, 10 assets (11% of total balance) with NOI debt yield between 12% and 14%, 2 assets (1% of total balance) with NOI debt yield between 14% and 16%, 5 assets (7% of total balance) with NOI debt yield between 16% and 18%, 1 assets (0% of total balance) with NOI debt yield between 18% and 20% and 1 assets (0% of total balance) with NOI debt yield between 20% and 22%.

NCF DSCR ranged from 0.0x to 4.0x. There were 2 assets (1.5% of total balance) with NCF DSCR between 0.5x and 1.0x, 19 assets (35.2% of total balance) with NCF DSCR between 1.0x and 1.5x, 20 assets (25.7% of total balance) with NCF DSCR between 1.5x and 2.0x, 18 assets (30.1% of total balance) with NCF DSCR between 2.0x and 2.5x, 4 assets (6.0% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (0.2% of total balance) with NCF DSCR between 3.0x and 3.5x and 2 assets (1.2% of total balance) with NCF DSCR between 3.5x and 4.0x. The most recent weighted average NCF DSCR was 1.9x.







DSCRs ranged from 0.5x to 4.5x.There are 2 assets (1.5% of total balance) with DSCR between 0.5x and 1.0x, 9 assets (15.1% of total balance) with DSCR between 1.0x and 1.5x, 23 assets (33.1% of total balance) with DSCR between 1.5x and 2.0x, 21 assets (34.5% of total balance) with DSCR between 2.0x and 2.5x, 7 assets (13.9% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (0.7% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.8% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (0.4% of total balance) with DSCR between 4.0x and 4.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
