# **Transaction Summary**

The transaction closed on Jun 19 2019 and matures in May 2030. The pool's current aggregate principal balance is \$1534.5 million compared to \$1543.3 million at close.

The largest loan of the pool (4.2%) is secured by 9201 West Sunset Boulevard located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 97%. The major tenants included HH SUNSET INNOVATIVE DINNING (7.87%) and ONCOTHERAPEUTICS (6.67%). The second largest loan of the pool (4.2%) is secured by SoCal Retail Portfolio located in Los Angeles-Long Beach-Glendale, CA-61.32% metropolitan area. Occupancy at the subject was 98%. The major tenants included Home Depot (10.10%) and Target (9.05%). The third largest loan of the pool (4.0%) is secured by Marriott San Diego Mission Valley located in metropolitan area. Occupancy at the subject was 35%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.30% and 35 months as of 03/15/2022, respectively. There are a total of 46 loans and 255 properties in the portfolio. The appraisal LTV was approximately 57.9% compared to the Original loan to value (LTV), which was approximately 58.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.83x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.






## Local Distribution









# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
