## Transaction Summary

The transaction closed on Jul 25 2019 and matures in May 2030. The pool's current aggregate principal balance is \$743.6 million compared to \$747.1 million at close.

The largest loan of the pool (9.4%) is secured by Grand Canal Shoppes - Trust located in metropolitan area. Occupancy at the subject was 86%. The major tenants included Venetian Casino Resort (5.60%) and The Venetian Resort (Showroom / Theater) (5.10%). The second largest loan of the pool (8.1%) is secured by SoCal Retail Portfolio located in Los Angeles-Long Beach-Glendale, CA-66.34% metropolitan area. Occupancy at the subject was 99%. The major tenants included Home Depot (10.10%) and Target (9.05%). The third largest loan of the pool (5.9%) is secured by Embassy Suites at Centennial Olympic Park located in metropolitan area. Occupancy at the subject was 83%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.42% and 16 months as of 10/15/2020, respectively. There are a total of 53 loans and 85 properties in the portfolio. The appraisal LTV was approximately 61.0% compared to the Original loan to value (LTV), which was approximately 59.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.90x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.

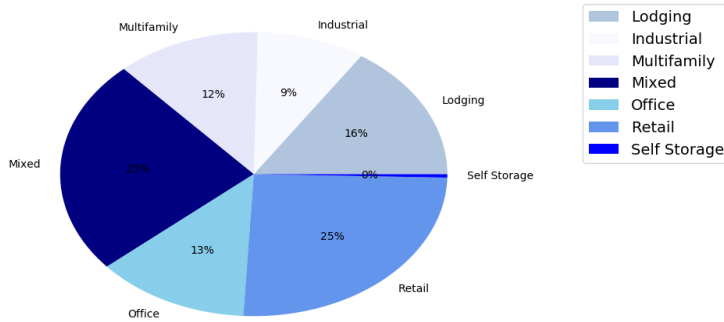

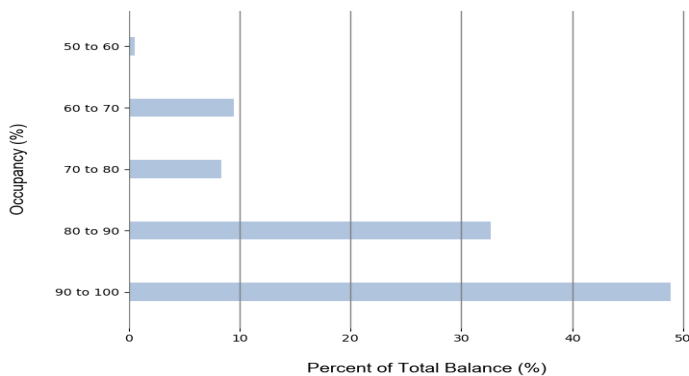

Occupancy Distribution (%)

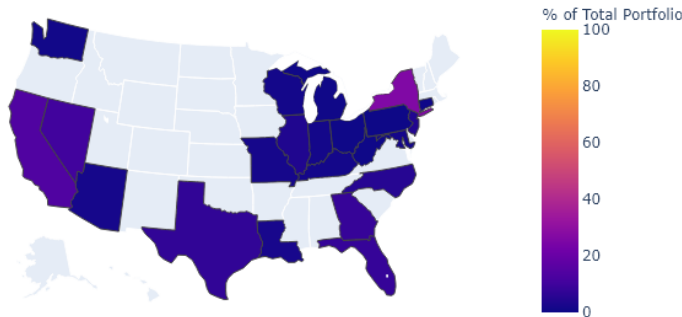

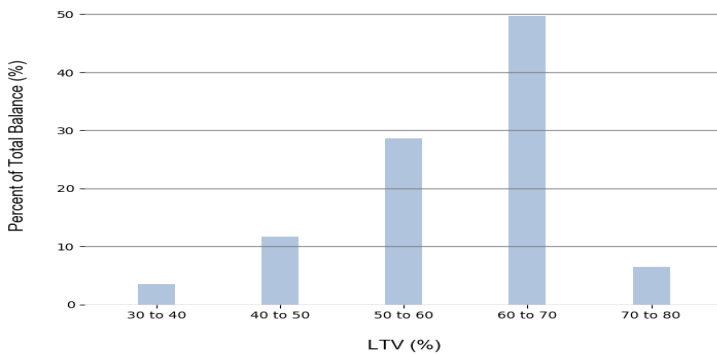
Local Distribution

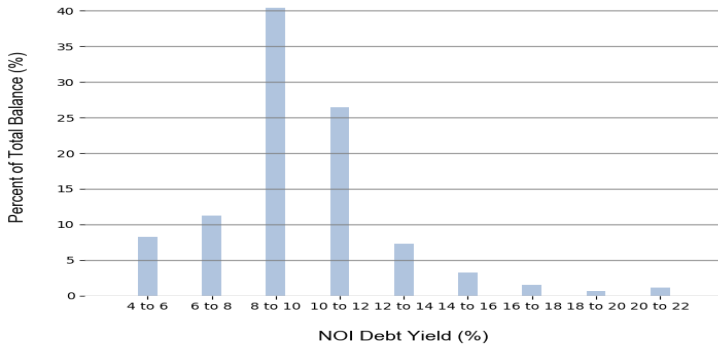

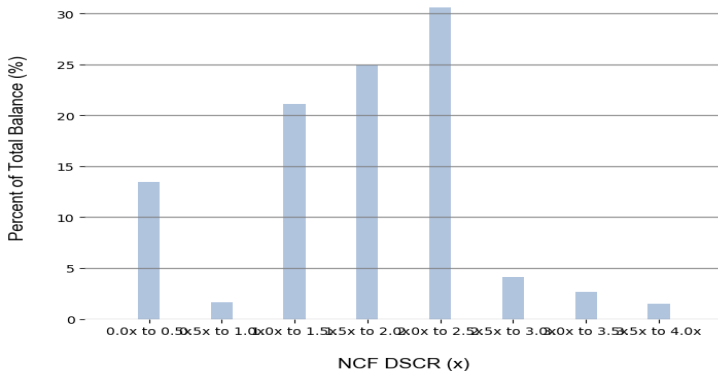
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 4% to 21% with a weighted average NOI debt yield of 9.8%. NOI debt yield ranged from 4% to 21%. There were 5 assets (8% of total balance) with NOI debt yield between 4% and 6%, 7 assets (11% of total balance) with NOI debt yield between 6% and 8%, 17 assets (40% of total balance) with NOI debt yield between 8% and 10%, 15 assets (26% of total balance) with NOI debt yield between 10% and 12%, 4 assets (7% of total balance) with NOI debt yield between 12% and 14%, 2 assets (3% of total balance) with NOI debt yield between 14% and 16%, 1 assets (1% of total balance) with NOI debt yield between 16% and 18%, 1 assets (1% of total balance) with NOI debt yield between 18% and 20% and 1 assets (1% of total balance) with NOI debt yield between 20% and 22%.

Net Cash Flow DSCR (x)

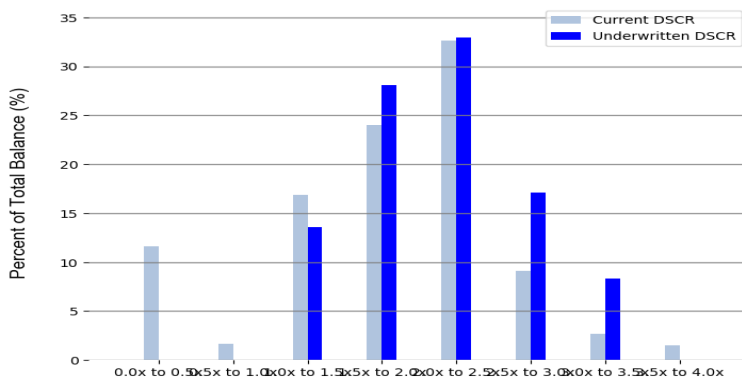

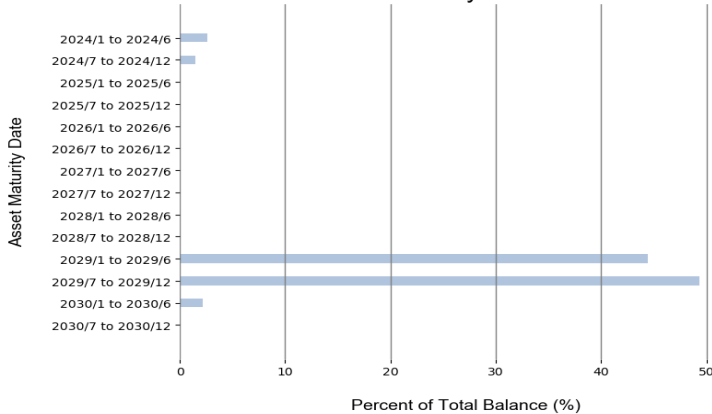
DSCR Distribution (x)

There are 5 assets (11.6% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (1.6% of total balance) with DSCR between 0.5x and 1.0x, 12 assets (16.9% of total balance) with DSCR between 1.0x and 1.5x, 12 assets (24.0% of total balance) with DSCR between 1.5x and 2.0x, 13 assets (32.6% of total balance) with DSCR between 2.0x and 2.5x, 8 assets (9.1% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (2.7% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (1.5% of total balance) with DSCR between 3.5x and 4.0x. There are 2 assets (2.6% of total balance) that have maturity dates between 2024/1 and 2024/6, 1 assets (1.5% of total balance) that have maturity dates between 2024/7 and 2024/12, 30 assets (44.4% of total balance) that have maturity dates between 2029/1 and 2029/6, 19 assets (49.3% of total balance) that have maturity dates between 2029/7 and 2029/12 and 1 assets (2.2% of total balance) that have maturity dates between 2030/1 and 2030/6.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
