Transaction Summary

The transaction closed on Nov 21 2019 and matures in Nov 2029. The pool's current aggregate principal balance is \$1019.9 million compared to \$1021.2 million at close.

The largest loan of the pool (6.9%) is secured by GNL Office and Industrial Portfolio located in Los Angeles-Long Beach-Glendale, CA-27.38% Detroit-Dearborn-Livonia, MI-5.25% metropolitan area. Occupancy at the subject was 100%. The major tenants included At&T san antonio TX (18.29%) and Hanes Co - Calhoun GA (12.55%). The second largest loan of the pool (6.9%) is secured by Parklawn Building located in Silver Spring-Frederick-Rockville, MD metropolitan area. Occupancy at the subject was 73%. The largest tenant was United States Government (72.87%). The third largest loan of the pool (5.9%) is secured by East Village Multifamily Portfolio located in New York-Jersey City-White Plains, NY-NJ-100.00% metropolitan area. Occupancy at the subject was 99%. The major tenants included 7-11 (0.00%) and Stand-Up MRI of Manhattan (0.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.68% and 14 months as of 12/15/2020, respectively. There are a total of 51 loans and 100 properties in the portfolio. The appraisal LTV was approximately 59.0% compared to the Original loan to value (LTV), which was approximately 59.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.06x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 93%.

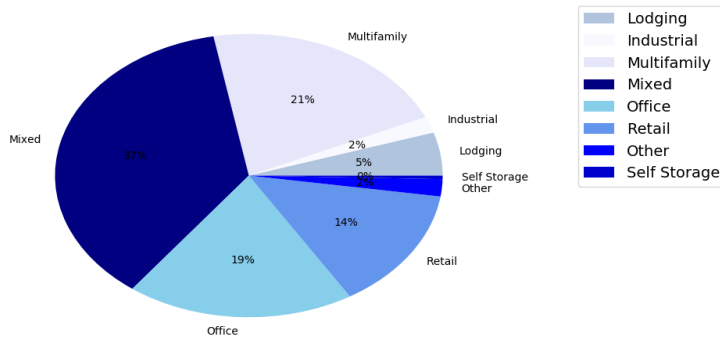

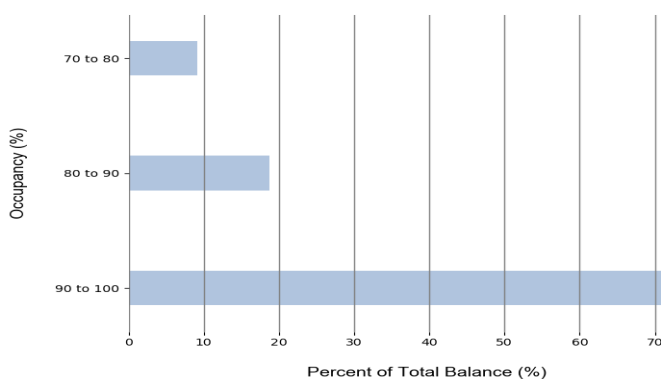

Occupancy Distribution (%)

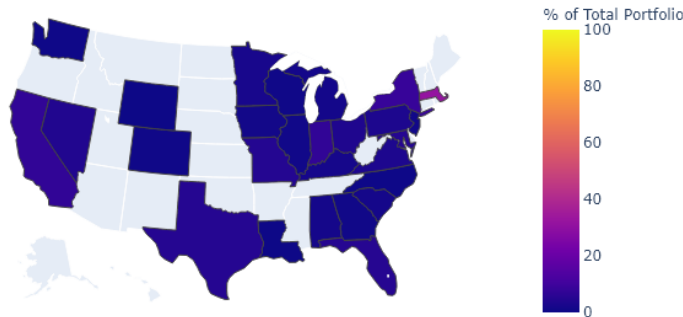

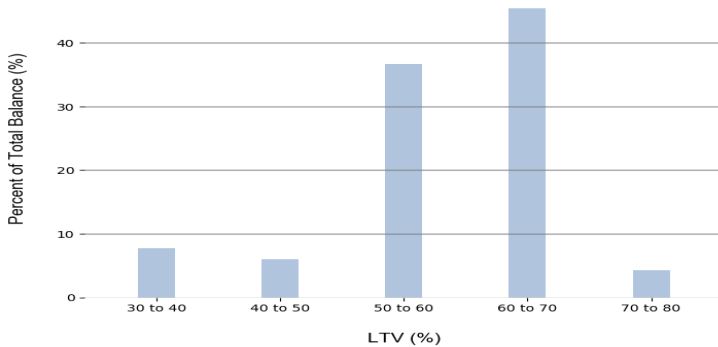
Local Distribution

LTV Distribution (%)



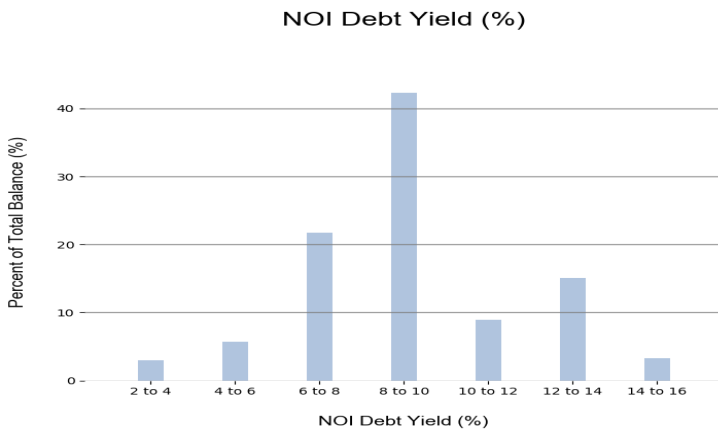

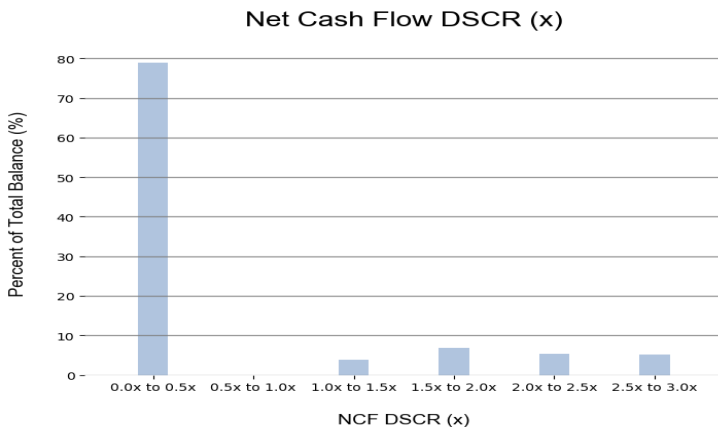

Most recent net operating income debt yield ranged from 2% to 15% with a weighted average NOI debt yield of 9.3%. NOI debt yield ranged from 2% to 15%. There were 1 assets (3% of total balance) with NOI debt yield between 2% and 4%, 3 assets (6% of total balance) with NOI debt yield between 4% and 6%, 7 assets (22% of total balance) with NOI debt yield between 6% and 8%, 21 assets (42% of total balance) with NOI debt yield between 8% and 10%, 8 assets (9% of total balance) with NOI debt yield between 10% and 12%, 9 assets (15% of total balance) with NOI debt yield between 12% and 14% and 2 assets (3% of total balance) with NOI debt yield between 14% and 16%.

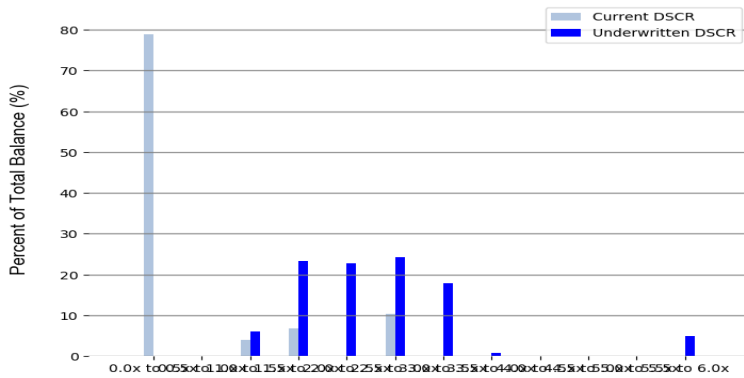

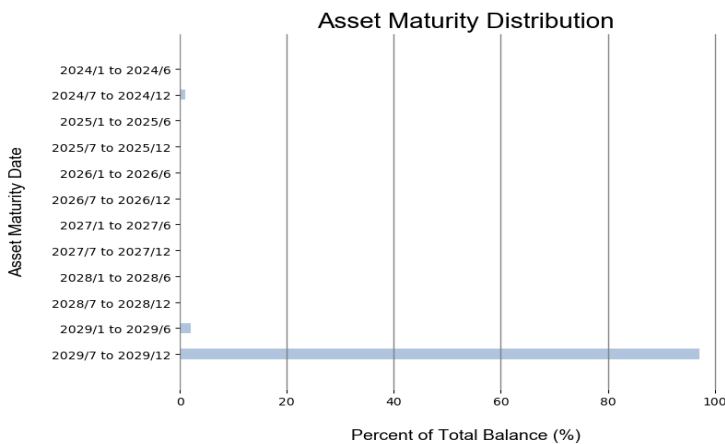

There are 46 assets (78.8% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (3.9% of total balance) with DSCR between 1.0x and 1.5x, 1 assets (6.9% of total balance) with DSCR between 1.5x and 2.0x and 3 assets (10.4% of total balance) with DSCR between 2.5x and 3.0x. The most recent weighted average DSCR is 2.2x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
