Transaction Summary

The transaction closed on Nov 21 2019 and matures in Nov 2029. The pool's current aggregate principal balance is \$1017.9 million compared to \$1021.2 million at close.

The largest loan of the pool (6.9%) is secured by GNL Office and Industrial Portfolio located in Los Angeles-Long Beach-Glendale, CA-27.38% Detroit-Dearborn-Livonia, MI-5.25% metropolitan area. Occupancy at the subject was 100%. The major tenants included AT&T (18.29%) and Hanes Co - Calhoun GA (12.55%). The second largest loan of the pool (6.9%) is secured by Parklawn Building located in Silver Spring-Frederick-Rockville, MD metropolitan area. Occupancy at the subject was 73%. The largest tenant was United States Government (72.87%). The third largest loan of the pool (5.9%) is secured by East Village Multifamily Portfolio located in New York-Jersey City-White Plains, NY-NJ-100.00% metropolitan area. Occupancy at the subject was 82%. The major tenants included 7-11 (0.00%) and Stand-Up MRI of Manhattan (0.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.68% and 29 months as of 03/15/2022, respectively. There are a total of 51 loans and 100 properties in the portfolio. The appraisal LTV was approximately 58.9% compared to the Original loan to value (LTV), which was approximately 59.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.36x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 2% to 17% with a weighted average NOI debt yield of 9.3%. NOI debt yield ranged from 2% to 17%. There were 1 assets (1% of total balance) with NOI debt yield between 2% and 4%, 4 assets (9% of total balance) with NOI debt yield between 4% and 6%, 7 assets (20% of total balance) with NOI debt yield between 6% and 8%, 13 assets (30% of total balance) with NOI debt yield between 8% and 10%, 15 assets (25% of total balance) with NOI debt yield between 10% and 12%, 9 assets (10% of total balance) with NOI debt yield between 12% and 14%, 1 assets (5% of total balance) with NOI debt yield between 14% and 16% and 1 assets (1% of total balance) with NOI debt yield between 16% and 18%.

NCF DSCR ranged from 0.0x to 5.5x. There were 2 assets (2.0% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (3.7% of total balance) with NCF DSCR between 0.5x and 1.0x, 3 assets (7.2% of total balance) with NCF DSCR between 1.0x and 1.5x, 11 assets (21.9% of total balance) with NCF DSCR between 1.5x and 2.0x, 14 assets (28.8% of total balance) with NCF DSCR between 2.0x and 2.5x, 8 assets (11.8% of total balance) with NCF DSCR between 2.5x and 3.0x, 9 assets (19.1% of total balance) with NCF DSCR between 3.0x and 3.5x, 1 assets (0.6% of total balance) with NCF DSCR between 4.5x and 5.0x and 1 assets (4.9% of total balance) with NCF DSCR between 5.0x and 5.5x. 



There are 1 assets (0.8% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (2.2% of total balance) with DSCR between 0.5x and 1.0x, 3 assets (9.5% of total balance) with DSCR between 1.0x and 1.5x, 11 assets (21.3% of total balance) with DSCR between 1.5x and 2.0x, 8 assets (17.9% of total balance) with DSCR between 2.0x and 2.5x, 12 assets (22.0% of total balance) with DSCR between 2.5x and 3.0x, 12 assets (20.9% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.6% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (4.9% of total balance) with DSCR between 5.0x and 5.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
