Transaction Summary

The transaction closed on Feb 20 2020 and matures in Feb 2030. The pool's current aggregate principal balance is \$828.6 million compared to \$830.5 million at close.

The largest loan of the pool (7.8%) is secured by Bellagio Hotel and Casino - Trust located in metropolitan area. Occupancy at the subject was 56%. The second largest loan of the pool (7.2%) is secured by 545 Washington Boulevard located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 96%. The major tenants included INSURANCE SERVICE (40.70%) and JPMorgan Chase (39.67%). The third largest loan of the pool (7.2%) is secured by Royal Palm Place located in West Palm Beach-Boca Raton-Delray Beach, FL metropolitan area. Occupancy at the subject was 96%. The major tenants included Residental occupied (55.43%) and CHOPS BOCA RATON LLC. (2.25%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.69% and 27 months as of 04/15/2022, respectively. There are a total of 40 loans and 67 properties in the portfolio. The appraisal LTV was approximately 58.0% compared to the Original loan to value (LTV), which was approximately 58.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.01x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.





Occupancy Distribution (%)




Local Distribution









DSCRs ranged from 0.0x to 4.0x.There are 1 assets (6.8% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (0.5% of total balance) with DSCR between 0.5x and 1.0x, 3 assets (3.8% of total balance) with DSCR between 1.0x and 1.5x, 13 assets (30.4% of total balance) with DSCR between 1.5x and 2.0x, 12 assets (34.5% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (9.5% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (5.9% of total balance) with DSCR between 3.0x and 3.5x and 2 assets (8.6% of total balance) with DSCR between 3.5x and 4.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
