The transaction closed on Oct 30 2019 and matures in Oct 2024. The pool's current aggregate principal balance is \$218.1 million compared to \$218.1 million at close.

The single asset of the pool is secured by Patriots Park located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 100%. The largest tenant was United States Government (97.55%).


The weighted average coupon (WAC) and the weighted average age (WALA) were 3.35% and 14 months as of 12/15/2020, respectively. There are a total of 1 loans and 1 properties in the portfolio. The appraisal LTV was approximately 69.0% compared to the Original loan to value (LTV), which was approximately 69.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.40x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 100%.






Occupancy Distribution (%)



Among all the assets in the portfolio, 100% of total balance had LTVs between 60% and 70%.









EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
