Transaction Summary

The transaction closed on Jul 19 2016 and matures in Oct 2045. The pool's current aggregate principal balance is \$709.6 million compared to \$739.1 million at close.

The largest loan of the pool (5.6%) is secured by The Mall at Rockingham Park - Pooled located in Rockingham County-Strafford County, NH metropolitan area. Occupancy at the subject was 96%. The major tenants included Lord & Taylor (29.32%) and Forever 21 (2.11%). The second largest loan of the pool (5.4%) is secured by 85 Bluxome located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 100%. The largest tenant was Collective Inc. (100.00%). The third largest loan of the pool (5.1%) is secured by 26 Astor Place located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 99%. The major tenants included JPMorgan Chase (46.29%) and LAFAYETTE GROUP INC (41.71%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.87% and 55 months as of 12/10/2020, respectively. There are a total of 47 loans and 138 properties in the portfolio. The appraisal LTV was approximately 61.8% compared to the Original loan to value (LTV), which was approximately 61.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.83x. As of 12/10/2020, 2.53% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.

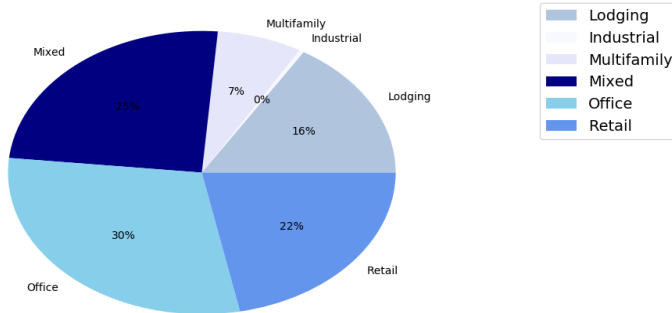

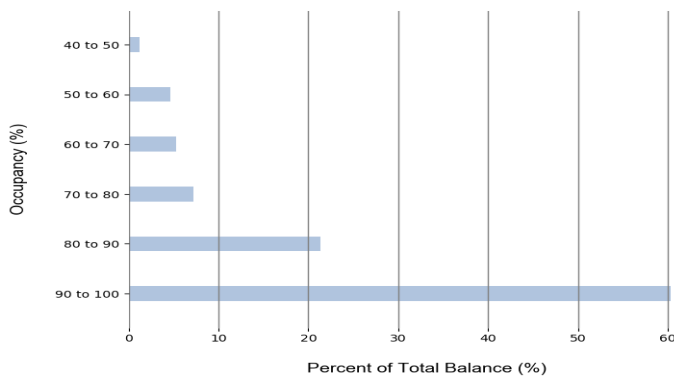

Occupancy Distribution (%)

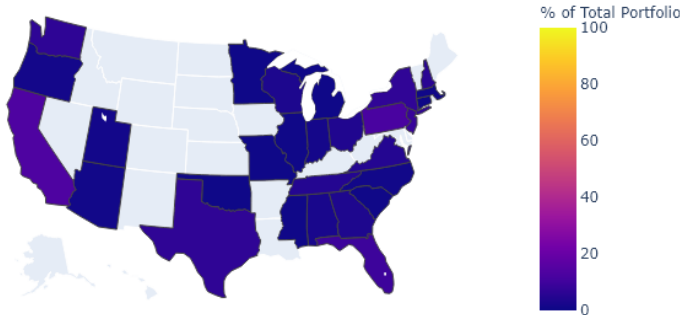

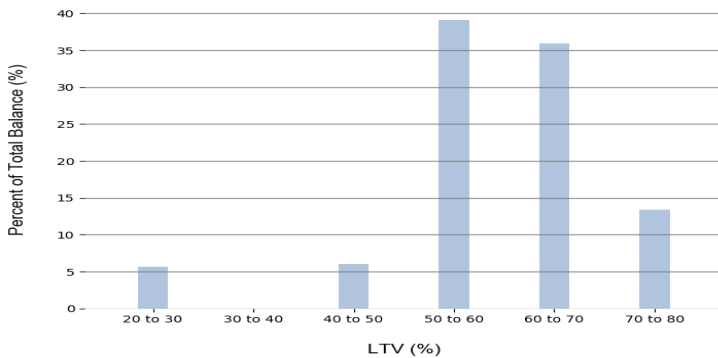
Local Distribution

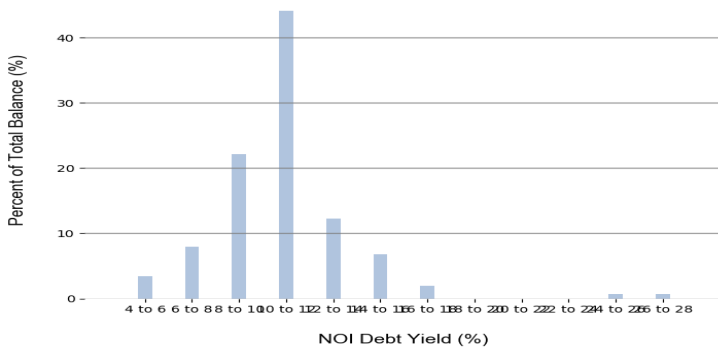

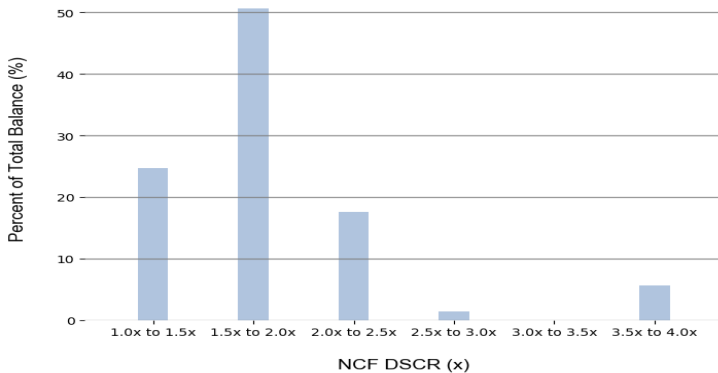
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 4% to 27% with a weighted average NOI debt yield of 11.2%. NOI debt yield ranged from 4% to 27%. Net Cash Flow DSCR (x)

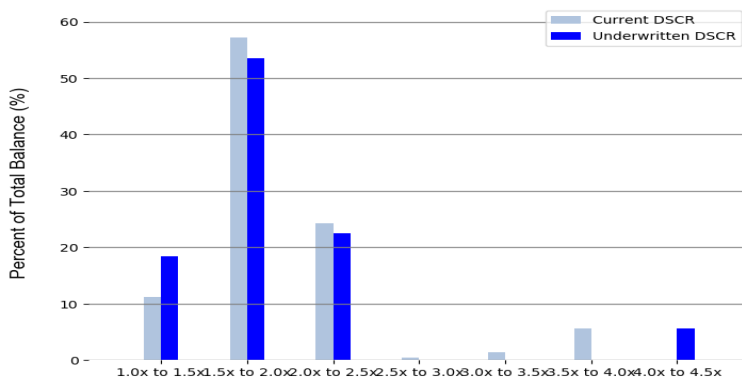


All assets in the portfolio had net cash flow debt service coverage ratios (NCF DSCR) higher than 1x. NCF DSCR ranged from 1.0x to 4.0x. There were 14 assets (24.7% of total balance) with NCF DSCR between 1.0x and 1.5x, 24 assets (50.7% of total balance) with NCF DSCR between 1.5x and 2.0x, 6 assets (17.6% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (1.4% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (5.6% of total balance) with NCF DSCR between 3.5x and 4.0x. The most recent weighted average NCF DSCR was 1.8x.

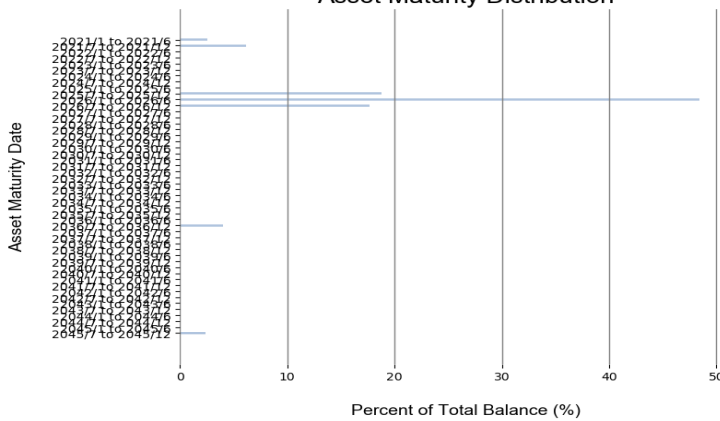
DSCR Distribution (x)



DSCRs ranged from 1.0x to 4.0x. There are 6 assets (11.2% of total balance) with DSCR between 1.0x and 1.5x, 30 assets (57.2% of total balance) with DSCR between 1.5x and 2.0x, 7 assets (24.2% of total balance) with DSCR between 2.0x and 2.5x, 1 assets (0.4% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (1.4% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (5.6% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 1.9x.

There are 3 assets (2.5% of total balance) that have maturity dates between 2021/1 and 2021/6, 2 assets (6.2% of total balance) that have maturity dates between 2021/7 and 2021/12, 9 assets (18.8% of total balance) that have maturity dates between 2025/7 and 2025/12, 24 assets (48.4% of total balance) that have maturity dates between 2026/1 and 2026/6, 7 assets (17.7% of total balance) that have maturity dates between 2026/7 and 2026/12, 1 assets (4.0% of total balance) that have maturity dates between 2036/7 and 2036/12 and 1 assets (2.4% of total balance) that have maturity dates between 2045/7 and 2045/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
