## **Transaction Summary**

The transaction closed on Jun 12 2017 and matures in Jun 2027. The pool's current aggregate principal balance is \$876.9 million compared to \$905.9 million at close.

The largest loan of the pool (4.9%) is secured by GM Logistics Center 1 located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was General Motors (100.00%). The second largest loan of the pool (4.6%) is secured by Moffett Place Google located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Google (100.00%). The third largest loan of the pool (4.0%) is secured by Garden Village located in Oakland-Hayward-Berkeley, CA metropolitan area. Occupancy at the subject was 100%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.87% and 44 months as of 12/15/2020, respectively. There are a total of 65 loans and 94 properties in the portfolio. The appraisal LTV was approximately 59.7% compared to the Original loan to value (LTV), which was approximately 58.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.87x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.





## Occupancy Distribution (%)




#### Local Distribution









# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
