# **Transaction Summary**

The transaction closed on Aug 17 2017 and matures in Jun 2032. The pool's current aggregate principal balance is \$802.2 million compared to \$836.2 million at close.

The largest loan of the pool (6.2%) is secured by General Motors Building - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 91%. The major tenants included Weil, Gotshal & Manges (24.60%) and Aramis (15.10%). The second largest loan of the pool (6.2%) is secured by Park West Village located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 80%. The third largest loan of the pool (6.1%) is secured by TZA Multifamily Portfolio I located in metropolitan area. Occupancy at the subject was 97%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.41% and 56 months as of 03/15/2022, respectively. There are a total of 57 loans and 167 properties in the portfolio. The appraisal LTV was approximately 54.0% compared to the Original loan to value (LTV), which was approximately 55.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.85x. As of 03/15/2022, 9.39% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 82%.





# Occupancy Distribution (%)




#### Local Distribution









# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
