## **Transaction Summary**

The transaction closed on Aug 31 2017 and matures in Aug 2027. The pool's current aggregate principal balance is \$680.8 million compared to \$708.8 million at close.

The largest loan of the pool (7.5%) is secured by Ionis Pharmaceuticals - Gazelle Ct located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was IONIS GAZELLE LLC (100.00%). The second largest loan of the pool (7.3%) is secured by Del Amo Fashion Center located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 88%. The major tenants included J.C. Penney (9.20%) and Nordstrom (7.80%). The third largest loan of the pool (7.2%) is secured by TZA Multifamily Portfolio I located in metropolitan area. Occupancy at the subject was 97%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.32% and 57 months as of 04/15/2022, respectively. There are a total of 42 loans and 62 properties in the portfolio. The appraisal LTV was approximately 52.9% compared to the Original loan to value (LTV), which was approximately 54.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.27x. As of 04/15/2022, 14.03% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 83%.





## Occupancy Distribution (%)




#### Local Distribution









There are 1 assets (1.9% of total balance) with DSCR between -0.5x and 0.0x, 5 assets (11.2% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (0.4% of total balance) with DSCR between 0.5x and 1.0x, 11 assets (17.8% of total balance) with DSCR between 1.0x and 1.5x, 12 assets (22.7% of total balance) with DSCR between 1.5x and 2.0x, 2 assets (0.9% of total balance) with DSCR between 2.0x and 2.5x, 1 assets (3.8% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (12.9% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (7.5% of total balance) with DSCR between 3.5x and 4.0x, 3 assets (15.1% of total balance) with DSCR between 4.0x and 4.5x, 1 assets (1.6% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (4.2% of total balance) with DSCR between 6.5x and 7.0x. There are 1 assets (37.0% of total balance) that have maturity dates between 2022/1 and 2022/6, 2 assets (58.5% of total balance) that have maturity dates between 2022/7 and 2022/12, 7 assets (119.6% of total balance) that have maturity dates between 2027/1 and 2027/6 and 32 assets (465.8% of total balance) that have maturity dates between 2027/7 and 2027/12.

# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
