## **Transaction Summary**

The transaction closed on Oct 18 2017 and matures in Oct 2031. The pool's current aggregate principal balance is \$3379.6 million compared to \$3396.0 million at close.

The largest loan of the pool (20.5%) is secured by 237 Park Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 99%. The major tenants included The New York and Presbyterian Hospital (38.27%) and JPMorgan Chase (21.61%). The second largest loan of the pool (1.4%) is secured by Preston Hollow located in Dallas-Plano-Irving, TX metropolitan area. Occupancy at the subject was 87%. The major tenants included Pediatric Associates Inc. (16.21%) and Trader Joe's (11.05%). The third largest loan of the pool (1.2%) is secured by Park West Village located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 94%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.93% and 41 months as of 12/15/2020, respectively. There are a total of 49 loans and 83 properties in the portfolio. The appraisal LTV was approximately 57.1% compared to the Original loan to value (LTV), which was approximately 54.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.37x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.






#### Local Distribution





Most recent net operating income debt yield ranged from 6% to 19% with a weighted average NOI debt yield of 9.5%. NOI debt yield ranged from 6% to 19%. There were 5 assets (3% of total balance) with NOI debt yield between 6% and 8%, 15 assets (79% of total balance) with NOI debt yield between 8% and 10%, 11 assets (9% of total balance) with NOI debt yield between 12% and 12%, 12 assets (5% of total balance) with NOI debt yield between 12% and 14%, 5 assets (3% of total balance) with NOI debt yield between 14% and 16%, 1 assets (0% of total balance) with NOI debt yield between 14% and 16%, 1 assets (0% of total balance) with NOI debt yield between 18% and 20%

There were 1 assets (0.4% of total balance) with NCF DSCR between 0.0x and 0.5x, 10 assets (3.2% of total balance) with NCF DSCR between 1.0x and 1.5x, 22 assets (15.8% of total balance) with NCF DSCR between 1.5x and 2.0x, 9 assets (59.2% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (1.2% of total balance) with NCF DSCR between 3.0x, 3 assets (18.0% of total balance) with NCF DSCR between 3.0x and 3.5x, 1 assets (1.2% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (1.1% of total balance) with NCF DSCR between 4.0x and 4.5x. 



DSCRs ranged from 0.0x to 5.0x. There are 1 assets (0.4% of total balance) with DSCR between 0.0x and 0.5x, 4 assets (1.5% of total balance) with DSCR between 1.0x and 1.5x, 22 assets (8.8% of total balance) with DSCR between 1.5x and 2.0x, 12 assets (65.6% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (2.7% of total balance) with DSCR between 2.5x and 3.0x, 4 assets (18.7% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (1.2% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (1.1% of total balance) with DSCR between 4.5x and 5.0x. The most recent weighted average DSCR is 2.5x.

There are 2 assets (7.2% of total balance) that have maturity dates between 2022/7 and 2022/12, 1 assets (0.1% of total balance) that have maturity dates between 2026/7 and 2026/12, 5 assets (53.3% of total balance) that have maturity dates between 2027/1 and 2027/6, 40 assets (38.8% of total balance) that have maturity dates between 2027/7 and 2027/12 and 1 assets (0.6% of total balance) that have maturity dates between 2031/7 and 2031/12.

# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
