Transaction Summary

The transaction closed on Feb 27 2018 and matures in Feb 2033. The pool's current aggregate principal balance is \$1033.3 million compared to \$1045.3 million at close.

The largest loan of the pool (5.8%) is secured by AFIN Portfolio located in metropolitan area. Occupancy at the subject was 92%. The major tenants included Kohl's Department Store (8.88%) and Best Buy (6.42%). The second largest loan of the pool (5.2%) is secured by Tryad Industrial & Business Center located in metropolitan area. Occupancy at the subject was 67%. The major tenants included Hammer Packaging Corp. (9.70%) and Maximus Inc. (5.70%). The third largest loan of the pool (4.8%) is secured by CrossPoint located in Cambridge-Newton-Framingham, MA metropolitan area. Occupancy at the subject was 94%. The major tenants included Kronos Incorporated Ph 2 (11.08%) and Arris Technology Inc. (10.88%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.72% and 35 months as of 12/15/2020, respectively. There are a total of 67 loans and 126 properties in the portfolio. The appraisal LTV was approximately 59.0% compared to the Original loan to value (LTV), which was approximately 59.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.92x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.

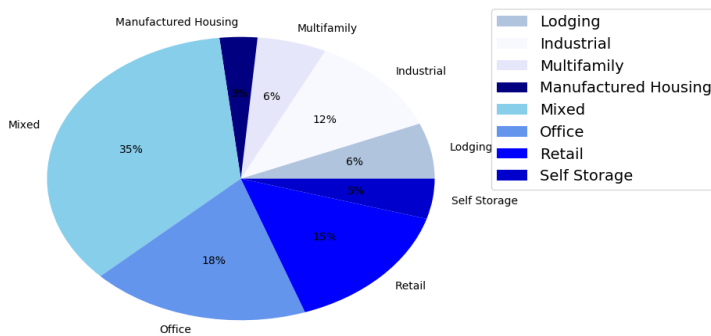

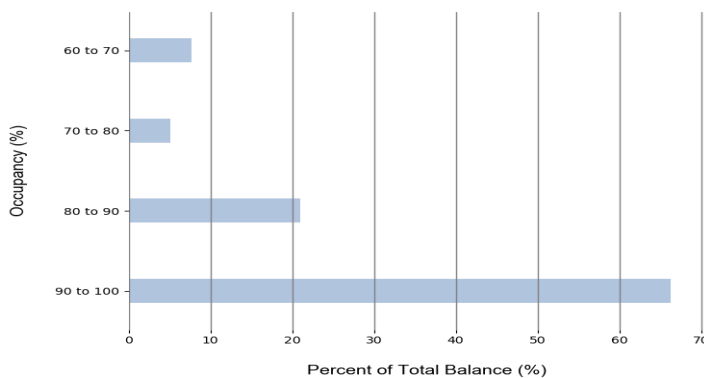

Occupancy Distribution (%)

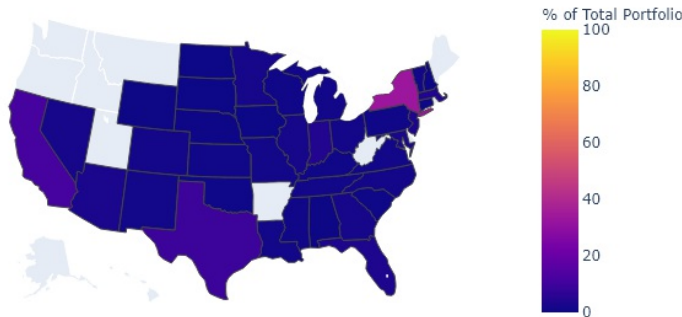

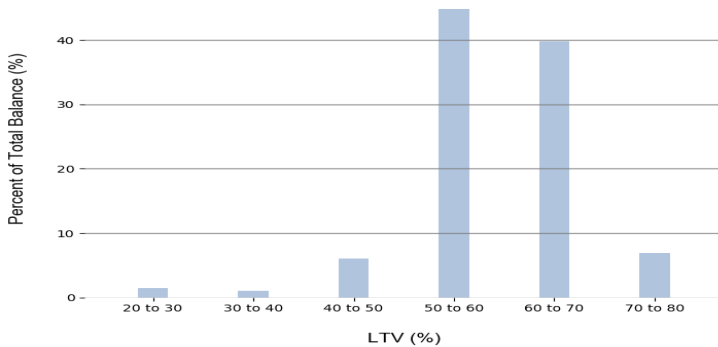
Local Distribution

LTV Distribution (%)



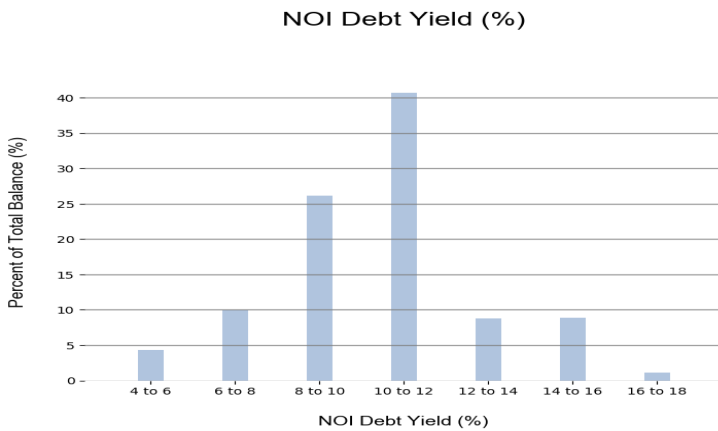

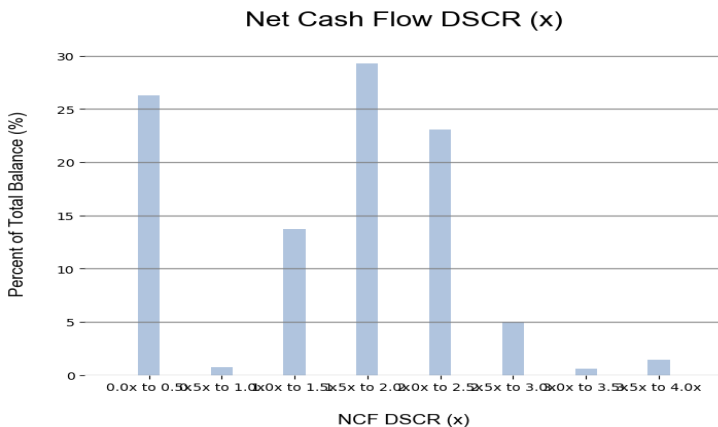

Most recent net operating income debt yield ranged from 4% to 17% with a weighted average NOI debt yield of 10.5%. NOI debt yield ranged from 4% to 17%. There were 1 assets (4% of total balance) with NOI debt yield between 4% and 6%, 6 assets (10% of total balance) with NOI debt yield between 6% and 8%, 23 assets (26% of total balance) with NOI debt yield between 8% and 10%, 26 assets (41% of total balance) with NOI debt yield between 10% and 12%, 5 assets (9% of total balance) with NOI debt yield between 12% and 14%, 5 assets (9% of total balance) with NOI debt yield between 14% and 16% and 1 assets (1% of total balance) with NOI debt yield between 16% and 18%.

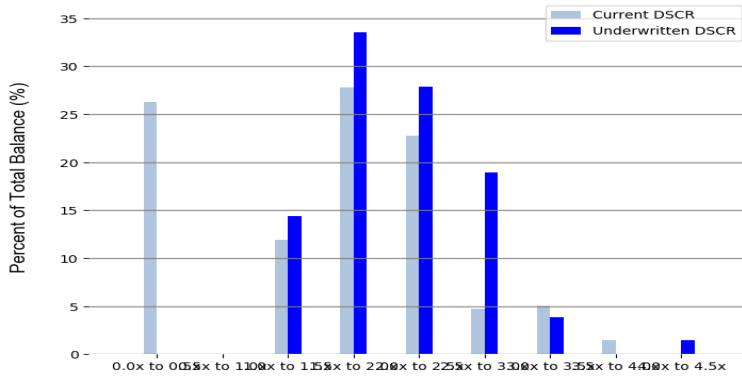

There were 12 assets (26.3% of total balance) with NCF DSCR between 0.0x and 0.5x, 1 assets (0.7% of total balance) with NCF DSCR between 0.5x and 1.0x, 11 assets (13.7% of total balance) with NCF DSCR between 1.0x and 1.5x, 24 assets (29.3% of total balance) with NCF DSCR between 1.5x and 2.0x, 14 assets (23.0% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (4.9% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (0.6% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (1.5% of total balance) with NCF DSCR between 3.5x and 4.0x. 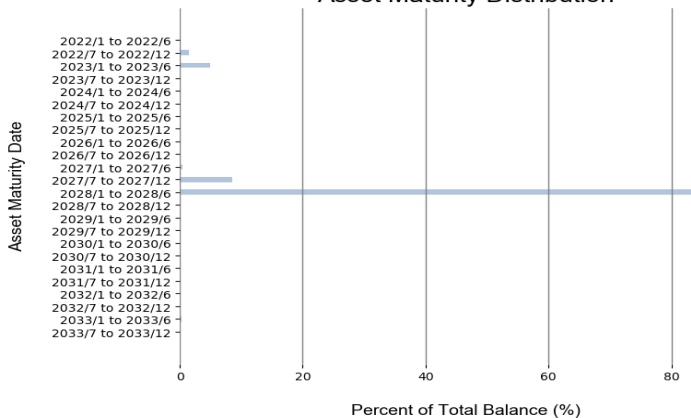
DSCR Distribution (x)



DSCRs ranged from 0.0x to 4.0x. There are 12 assets (26.3% of total balance) with DSCR between 0.0x and 0.5x, 9 assets (11.9% of total balance) with DSCR between 1.0x and 1.5x, 23 assets (27.8% of total balance) with DSCR between 1.5x and 2.0x, 15 assets (22.7% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (4.7% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (5.1% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (1.5% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 2.1x.

There are 1 assets (1.5% of total balance) that have maturity dates between 2022/7 and 2022/12, 4 assets (4.9% of total balance) that have maturity dates between 2023/1 and 2023/6, 1 assets (0.4% of total balance) that have maturity dates between 2027/1 and 2027/6, 7 assets (8.5% of total balance) that have maturity dates between 2027/7 and 2027/12, 51 assets (84.5% of total balance) that have maturity dates between 2028/1 and 2028/6 and 3 assets (0.3% of total balance) that have maturity dates between 2033/1 and 2033/6.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
