## **Transaction Summary**

The transaction closed on Feb 27 2018 and matures in Feb 2033. The pool's current aggregate principal balance is \$1019.7 million compared to \$1039.8 million at close.

The largest loan of the pool (5.9%) is secured by AFIN Portfolio located in metropolitan area. Occupancy at the subject was 89%. The major tenants included Kohl's Department Store (6.99%) and Best Buy (6.42%). The second largest loan of the pool (5.2%) is secured by Tryad Industrial & Business Center located in metropolitan area. Occupancy at the subject was 66%. The major tenants included Hammer Packaging Corp. (9.70%) and Harris Corporation (7.59%). The third largest loan of the pool (4.9%) is secured by CrossPoint located in Cambridge-Newton-Framingham, MA metropolitan area. Occupancy at the subject was 94%. The major tenants included VERIZON NE (12.24%) and KRONOS INCORPORATED PH 2 (11.08%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.72% and 51 months as of 04/15/2022, respectively. There are a total of 66 loans and 122 properties in the portfolio. The appraisal LTV was approximately 58.8% compared to the Original loan to value (LTV), which was approximately 59.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.69x. As of 04/15/2022, 1.47% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.



Type Concentration









Most recent net operating income debt yield ranged from 4% to 19% with a weighted average NOI debt yield of 10.0%. NOI debt yield ranged from 4% to 19%. There were 6 assets (13% of total balance) with NOI debt yield between 4% and 6%, 5 assets (7% of total balance) with NOI debt yield between 6% and 8%, 24 assets (27% of total balance) with NOI debt yield between 8% and 10%, 19 assets (32% of total balance) with NOI debt yield between 10% and 12%, 6 assets (15% of total balance) with NOI debt yield between 12% and 14%, 3 assets (4% of total balance) with NOI debt yield between 14% and 16%, 2 assets (2% of total balance) with NOI debt yield between 16% and 18% and 1 assets (1% of total balance) with NOI debt yield between 18% and 20%.





There are 12 assets (26.5% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (3.3% of total balance) with DSCR between 0.5x and 1.0x, 9 assets (9.8% of total balance) with DSCR between 1.0x and 1.5x, 25 assets (36.0% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (13.4% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (9.0% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (9.0% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (0.6% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (1.5% of total balance) with DSCR between 3.5x and 4.0x. # EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
